Ashok Kumar of Khalpara Vivekananda Road, P.S - Siliguri, Dist - DJG, (ii) Sujan Roy (24), S/O Atul Roy of Sishabari Nemajote, P.S - Matigara, Dist - Darjeeling to the effect that today on 20.05.2021 at 13:55 hrs myself along with force while performing lock down duty N.B.U.Gate No-2 area found that above noted accused persons were loitering at above noted area without wearing any face mask and without any rhyme and reason which is amounting to Non-Compliance of Govt. Order in c/w Covid-19 pandemic as declared by the State Govt by the State Government vide No. 647-ISS/2M-22/2020, dated - 15.05.2020. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Therefore, I pray before your kind honour that a specific case may kindly be started against the accused persons (i) Saroj Kumar (18), S/O Lt. Ashok Kumar of Khalpara Vivekananda Road, P.S - Siliguri, Dist - DJG, (ii) Sujan Roy (24), S/O Atul Roy of Sishabari Nemajote, P.S - Matigara, Dist - Darjeeling under proper section of law and arrange for its investigation.
