In producing herewith four accused persons namely (1) Ganesh Barui(43yrs) S/O Lt. Sunil Barui of Niranjan Nagar, Ward No. 36, PO- Chugumali, PS- Bhaktinagar, Jalpaiguri (2) Atul Roy (55 yrs) S/O Lt. Kanta Roy of Siliguri Rathkhola Ward No. 22, P.O. Rabindra Sarani, PS- Siliguri, Darjeeling (3) Dinesh Mondal (59 yrs) S/O Lt. Deven Mondal of 10 No. Gajaldoba, P.O. Gajaldoba, PS- Malbazar, Jalpaiguri (4) Sapan Bose (47yrs) S/O Lt. Dhiren Bose of 10 No. Gajaldoba, P.O. Gajaldoba, PS- Malbazar, Jalpaiguri under arrest with Memo of Arrest.

I, SI. Phup Rinchey Bhutia of Ambari Falakata OP under NJP PS beg to report that on 18.05.2021 in course of my special mobile van duty vide Ambari OP GDE No- 633 and MCC No. 1167 Dated 18.05.2021 myself along with force namely (1) C/876 Ram Oraon and (2) NVF/130 Dhana Deb Roy had been to Nawapara More, under Ambari Falakata OP and performing Naka Checking Duty as per order of O/C. and found that the above noted persons were riding with their Motorcycles at Nawapara More and violated the Government Order (Lock Down) in c/w outbreak of COVID-19. Accordingly, the above noted persons were detained. On being interrogation they disclosed their identity as mentioned above and further they failed to give any satisfactory answer regarding their movement in that area rather they refuse to comply with direction of the Government Order regarding lockdown in c/w outbreak of COVID-19. Hence, I Seized their Motorcycle i.e. 1) TVS Motorcyclé No. WB-72R-4724 black colour (2) One super Splender Motorcycle bearing registration no. WB-72L-4180 (3) One Hero Honda Motorcycle bearing registration no. WB-74R-2518 along with all documents of above noted Motorcycles and arrested them U/S 41 Cr.P.C after issuing copy of Memo of arrest and inform their ground of arrest.

Therefore, I pray before your good office that a specific case may kindly be started under proper section of Law against the above noted accused persons namely (1). Ganesh Barui(43yrs) (2) Atul Roy (55 yrs) (3) Dinesh Mondal (59 yrs) (4) Sapan Bose (47yrs) and arrange for its investigation.
