In producing herewith nine (09) arrested accused persons who disclosed their name & identity as (i) Saju Kr. Dey (40 yrs) S/O- Babul Kanti Dey of North Bharat Nagar, near Kartun Factory, PS-Siliguri, Dist-Darjeeling, (ii) Bijay Nuniya (27yrs) S/O- Narayan Nuniya, C/O- Ranjit Mahato of Thakkar, near Shiv Mandir, PS-Matigara, Dist-Darjeeling, (iii) Raju Ghosh (25yrs) S/O- Sanjit Ghosh of Sitalapara, Ward No-31, PS-NJP, Dist-Jalpaiguri, (iv) Mithun Barman (27yrs) S/O- Pulin Barman of Sastri Nagar, near Balkrishna Club, Ward No-41, PS-Bhaktinagar, Dist-Jalpaiguri, (v) Tapash Barman (29 yrs) S/O- Khiten Barman of Sitalapara, Ward No-31, PS-NJP, Dist-Jalpaiguri, (vi) Kusang Lama (52 yrs) S/O- Lt. Bir Bahadur Lama of Spring Site T.E, Kurseong, PS-Kurseong, Dist-Darjeeling, (vii) Deb Sarkar (38 yrs) S/O- Lt. Durga Charan Sarkar, C/O- Madan Adhikari of Santinagar, Boubazar, PS-Bhaktinagar, Dist-Jalpaiguri, (viii) Arnab Das (25 yrs) S/O- Ratan Das of Gopal More, near Himachal Sangha Club, Ward No-30, PS-Siliguri, Dist-Darjeeling & (ix) Md. Barkat (19 yrs) S/O- Md. Matiulla of Koila Depo, near Maszid, Ward No-7, PS-Siliguri, Dist-Darjeeling were moving alongwith their vehicles bearing Reg Nos. Viz (i) Toto Rickshaw white colour bearing No. WB 73F/4673, (ii) Toto Rickshaw red colour without number plat, (iii) Toto Rickshaw blue colour bearing No. WB 73A/7018, (iv) Toto Rickshaw blue colour without number plat, (v) Toto Rickshaw bearing No. WB 71TC/710, (vi) One white colour Wagner Car bearing No-WB 74AJ/0362, (vii) Toto Rickshaw green colour without number plat & (viii) one Honda unicorn Bike black colour bearing No-WB 74AX/4061. I SI Uttam Kumar Ghosh of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons, to the effect that, on 19.05.2021 at 10.45 hrs during my Spl. Mobile Van duty at Venus More area, Siliguri, found the above noted persons were moving and gathered alongwith their above noted vehicles without wearing mask on their face and without.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of India duly promulgated in order No. 40-3/2020-DM-1(A), Govt. of India Ministry of Home affairs dated 24.03.2020 & MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV dated 27.04.2020 and Govt. of West Bengal order no- 134-Pr. Sec (Tr) dated 04.06.2020 & Order no- 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of India duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
