In producing herewith seven (07) arrested accused persons who disclosed their name & identity as (i) Binod Gupta (45 yrs) S/O- Laxman Gupta of Champasari, Ward No-45, PS-Pradhan Nagar, Dist-Darjeeling, (ii) Roni Mandal (31yrs) S/O- Lt. Prodip Mandal of Shaktighar Road No-7, near Girls School, PS-NJP, Dist-Jalpaiguri, (iii) Paltu Saha (35yrs) S/O- Naren Saha of Ghogomali, Chayanpara, Ward No-37, PS-Bhaktinagar, Dist-Jalpaiguri, (iv) Swadhin Saha (45 yrs) S/O- Lt. Nepal Ch Saha of Chayanpara, Ghugumari Kali Saha, PS-Bhaktinagar, Dist-Jalpaiguri, (v) Rajat Das (23yrs) S/O- Nemai Das of 1 No Dabgram Colony, Ward No-20, near Kali Mandir, PS-Siliguri, Dist-Darjeeling, (vi) Jadav Das (18yrs) S/O- Sahadev Das of 1 No Dabgram Colony, near Kali Mandir, Ward No-20, PS-Siliguri, Dist-Darjeeling and (vii) Prabir Sarkar (32yrs) S/O- Lt. Kalipada Sarkar of Baribhasa, PS-NJP, Dist-Jalpaiguri were gathering/moving. One of them, namely Prabir Sarkar moving there with his TOTO bearing Reg. No-WB- 71TC/709. I SI Mihir Majumder of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons, to the effect that, on 19.05.2021 at 11.05 hrs during my Spl. Mobile Van duty at Venus More area, Siliguri, found the above noted persons were moving and gathered there without wearing mask on their face.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of India duly promulgated in order No. 40-3/2020-DM-1(A), Govt. of India Ministry of Home affairs dated 24.03.2020 & MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV dated 27.04.2020 and Govt. of West Bengal order no- 134-Pr. Sec (Tr) dated 04.06.2020 & Order no- 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of India duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accourding, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
