In this regard I beg to state that today i.e. 19.05.21 at about 12.30hrs during my SPL mobile van duty at TOP area myself along with ASI Zinnat Ali, C/390 Sujit Paul and CVF/05 Gobinda Das all of Khalpara TOP-II under Siliguri PS had been to Jhankar More, Khalpara (This refers to Khalpara TOP GDE No-607 dated 19.05.21) and found that the above noted persons are opened their shops till 12.30hrs and huge no's of public gathered their shops on that area without any valid reason thereby violating the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, & order No-647-1SS/2M-22/2020 dated 15.05.21 with the view to control the spread of Pandemic of COVID-19 Corona virus.

The SL No-4 of the order of Govt of WB Order No-647-1SS/2M-22/2020 dated 15.05.21 is as here quote **"Retail shops & supplies, bazaars and hats relating to vegetables, fruits, groceries, milk bread, meat and eggs shall be allowed to remain open between -7 Am to 10 AM only"** Unquote.


When police team reached at Jhankar More Khalpara, seeing the police huge no of peoples fled away from the spot. During local enquiry it came to learn that the above noted persons opened their shops after violating the order. They are violating the Govt order which was passed with a view to stop from the spread of Pandemic COVID 19 corona virus. Accordingly I arrested above noted twelve shopkeepers and others from the spot after preparing proper arrest memo.

The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break-out of Pandemic COVID- 19 throughout the Country. Accordingly I arrested them after issuing proper arrest memo and maintaining health protocols ensure their safety and security.

So, I therefore request you for starting a specific case under proper section of law against the above noted arrested accused persons and arranged proper investigation of the case.
