Sir,

In producing here with 07 (Seven) arrested accused persons who disclosed their identity as (i) Lalu Prasad (24) yrs S/O-Jadhu Prasad of Nutan Para, Ramghat, Ward No-5, P.S-Siliguri, Dist. Darjeeling, ii) Anup Routh (24) yrs S/O-Sitaram Routh of Vidya Sagar Pally, Ward No-7, P.S-Siliguri, Dist. Darjeeling, iii) Prem Chandra Prasad (52) yrs. S/O-Late Ambika Prasad of Swaminagar Coloney, Ward No7, P.S-Siliguri, Dist. Darjeeling, iv) Raju Kamti (45) yrs.S/O-Late Langar Kamti of Cooli Para, Ward No-01, P.S-Pradhan Nagar, Dist. Darjeeling, v) Md. Miraj (34) yrs S/O-Md. Basir of Dangi Para, Near Over bridge, Ward NO-6, P.S-Siliguri, Dist. Darjeeling. vi) Jiwan Paul (55) yrs. S/O-Sri, Paresh Paul of Bagha Jyotin colo, Ward No-2, P.S-Siliguri, Dist. Darjeeling. and vii) Md. Munna (38) yrs. S/O-Md. Siraj of Adarsha Nagar, Ward NO-o-4, P.S-Siliguri, Dist. Darjeeling, and all the above noted accused persons arrested proper memo of arrest, in c/w above noted case reference.

I, SI. Upendra Nath Roy of Khalpara TOP under Siliguri PS, SPC do hereby lodge complaint against the above noted arrested persons, to the effect that on 20-05-21 at 12.25 hrs, myself along with force while performing Special mobile duty at Jalpai More, Siliguri area, Vide Khalpara TOP-II, GDE No-638 dated 20.05.21 and found that the above noted persons had made unnecessary gathering at the public places without wearing mask. On being asked the above noted persons stated that they were well aware of the COVID-19 pandemic situation and disobeyed the Govt guidelines without any valid reason.

Hence all of them violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation and to prevent spread of COVID-19 .. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID- 19 throughout the Country. Accordingly I arrested them after issuing proper arrest memo and maintaining health protocols ensure their safety and security.

So, I therefore request you for starting a specific case under proper section of law against the above noted arrested accused persons and arranged proper investigation of the case.
