In producing herewith eight (08) arrested accused persons who disclosed their name & identity as (i) Biswajit Saha (31yrs) S/O- Shyamal Saha of Bholamore, near Gas Godwon, PS-NJP, Dist-Jalpaiguri, (ii) Abhay Sarkar (40 yrs) S/O- Dipak Sarkar of 1 No Dabgram Colony, near Matri Sadan, PS-Siliguri, Dist-Darjeeling, (iii) Pabitra Das (38 yrs) S/O- Sushil Das of Sarkarpara, near Binayak Apartment, Ward No-41, PS-Bhaktinagar, Dist-Jalpaiguri, (iv) Ranjit Bhowmik (55 yrs) S/O- Lt. Pran Nath Bhowmik of Ambika Nagar, near School Math, PS-NJP, Dist-Jalpaiguri, (v) Sishir Roy (28 yrs) S/O- Biren Roy of Fuleswari, near Khanik Sangha, PS-Siliguri, Dist-Darjeeling, (vi) Anil Limbu (57 yrs) S/O- Lt. Joy Bahadur Limbu of Surya Sen Colony, Block-E, NJP main road, PS-NJP, Dist-Jalpaiguri, (vii) Raja Sarkar (41 yrs) S/O- Subhash Sarkar of Dadabhai Club more, Deshbandhupara, PS-Siliguri, Dist-Darjeeling, (viii) Papan Dutta (24 yrs) S/O- Krishna Dutta of Uttar kanyamore, Kamrangaguri, PS-NJP, Dist-Jalpaiguri alongwith their vehicles bearing Reg Nos. Viz (i) Toto Rickshaw blue colour without number, (ii) Toto Rickshaw green colour bearing No. WB 73F/1527, (iii) Toto Rickshaw brown colour without number, (iv) Toto Rickshaw sky blue without number, (v) Toto Rickshaw blue colour without number & (vi) Toto ricksaw blue colour bearing No- WB 73/0549. I, SI Uttam Kumar Baghira of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons, to the effect that, on 20.05.2021 at 12.35 hrs during my R/T Mobile Van duty at Siliguri Court More and others area under Siliguri PS found the above noted persons were moving/ gathered alongwith their vehicles noted above without wearing masks on their face.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of India duly promulgated in order No. 40-3/2020-DM-1(A), Govt. of India Ministry of Home affairs dated 24.03.2020 & MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV dated 27.04.2020 and Govt. of West Bengal order no- 134-Pr. Sec (Tr) dated 04.06.2020 & Order no- 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of India duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
