Dear Sir,

With due respect I Smt. Sefali Biswas, Wife of Md. Firoj, resident of Sahid Nagar, Near Holy Crown School, P.O Sevoke Road, Ward No. 43 of S.M.C., P.S Bhaktinagar, Dist. Jalpaiguri, would like to inform you that, my mother Smt. Lina Biswas was the owner of a tea stall situated at Upper Bhanu nagar, G.T. More, Opposite of Nanglo Bar. My mother was always stayed in her tea stall alongwith my elder sister namely Gouri Sai and they both have passed their life by selling tea, pan, gutkha alongwith street foods in their stall.

I would like to further inform you that, we have three brothers and three sisters but at the time of old age of my mother she has fallen in sick and I alongwith my elder sister repeatedly requested to my brothers for looking after of my mother and taking proper care and also requested them to pay some money as we can use the better treatment of my mother but my all brothers always neglect and refuse to do anything for treatment of my mother and on 05.04.2021 my mother has been died and after her demise my elder sister used to reside in the said tea stall.

I would like to further inform you that, recently my elder brother Sri Suraj Biswas alongwith his wife Jamuna Biswas has started to occupy the said shop room with deadly weapon and they started to sale 'Ganja' and 'Desi Daru' (local wine) from the said shop room, seeing the said illegality my sister tried to obstruct my said elder brother but he alongwith his wife always threatened with dire consequences if we or any one tried to obstruct them they will kill us in the middle of the road and no can resist them.

I would like to further inform you that, today at about 2.30 p.m. my elder brother alongwith his wife started to abuse filthy languages with a knife showing my elder sister and told her that they will kill her, finding no other alternative my elder sister called me when I reached there my brother started to using the said knife and firstly he attacked on my elder sister who became injured seeing the said situation I alongwith my husband tried to stop my elder brother, but he also attacked on me and my husband and we both got severe injury, my elder brother cut my husband's right arm and my face, and on that time one person who came out for helping us then my brother's wife threatened him if he will tried to help us then they will cut his hand also.

Finding no other alternative we called police and before reaching the police van they both left the said place and police personnel requested to take medical assistance and thereafter lodge a complaint. But when we all are going to Siliguri Hospital for treatment my said brother and his wife again came the said shop room and break the padlock and after entering they broke the all utensils, fridge, TV and other essential goods.

Under the above circumstances I would like to request you that take a serious action against the illegal act and activities of my elder brother and his wife otherwise they both will kill us as we are badly physical assault and said medical prescription are attached with this complain.
