I SI SK Tamzid Ali of Ashighar OP under Bhaktinager Police station, SPC do here by lodge a written complainant against six (06) accused persons namely (1) Shibu Mahanta (45) S/O Bishnu Pada Mohanta of Ghugumali W/no. 37 PS Bhaktinager Dist Jalpaiguri (2) Mithun Haldar (37) S/O Nikhil Haldar of Chayanpara Bazar W/no. 37 PS Bhaktinager Dist Jalpaiguri (3) Biswanath Sarkar (36) S/O Laltu Sarkar of 2 no. Jyoti Nagar W/no.40 PS Bhaktinager Dist Jalpaiguri (4) Ganesh Roy (65) S/O Late Jhatu Roy of Fakdaibari Bazar PS Bhaktinager Dist Jalpaiguri and (6) Sahadeb Sarkar (25) S/O Niranjan Sarkar of do, to the effect that today on 21.05.2021 at 07.55 hrs myself along with ASI Prahlad Singha C/1013 Sanjay Singha and CV/1016 Amrit Roy while performing patrolling duty in connection with Covid -19 situation at Ashighar OP area vide Ashighar OP GDE no. 432 Dt 21.05.2021, at about 12.55 hrs found that the above noted persons were roaming in OP area without wearing Mask and without any purpose which has been duly promulgated by Government of West Bengal due to crucial situation of corona virus though the Government has abstained them not to come out of the house without any emergency requirement as it is very dangerous for our society at this stage. As Government has announced wearing of facial mask has been made mandatory in public place in current pandemic disaster situation to everybody vide order no. 79-CS/2020 dated 12.04.2020, Vide memo no. 486-CS/2021 dt 24.04.2021 and also announced lock down from 16th may to 30th May vide memo no. 647-ISS/2M-22/2020 DT15.05.2021, as it is very dangerous for our society at this stage. However the above persons violated the said rules and norms which has been duly promulgated by Government of West Bengal. Considering the present situation of West Bengal as well as Whole India, I warned them to wear Mask and follow the protocol of COVID-19 & Govt. order but they did not pay heed to my words and did not comply my lawful instructions and kept on roaming within the area without wearing Mask. As such, I arrested them under the provision govt order after observing all sort of rules.

Therefore, I pray before your kind honour that a Specific case may kindly incited against the accused persons namely (1) Shibu Mahanta (45) S/O Bishnu Pada Mohanta of Ghugumali W/no. 37 PS Bhaktinager Dist Jalpaiguri (2) Mithun Haldar (37) S/O Nikhil Haldar of Chayanpara Bazar W/no. 37 PS Bhaktinager Dist Jalpaiguri (3) Biswanath Sarkar (36) S/O Laltu Sarkar of 2 no. Jyoti Nagar W/no.40 PS Bhaktinager Dist Jalpaiguri (4) Ganesh Roy (65) S/O Late Jhatu Roy of Fakdaibari Bazar PS Bhaktinager Dist Jalpaiguri (5) Ashit Mallick (24) S/O Ashutosh Mallick of Fakdaibari Mababhat PS Bhaktinager Dist Jalpaiguri and (6) Sahadeb Sarkar (25) S/O Niranjan Sarkar of do and arrange it investigation as per proper section of law.
