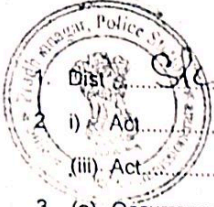

Sir,

I, ASI Ratan Pradhan of Pradhannagar PS, Siliguri Metropolitan Police, do hereby lodge this written complaint, on producing one arrested accused person namely Vishal Sah(M-18) S/o Late- Radha Sah of Darjeeling More, Ps Prdhan Nagar, Dist-Darjeeling under arrest along with following seized articles viz; 1. 10 (ten) bottles of King Fisher Strong Premium Beer containing @ 650 Ml. 2. 14 (Fourteen) bottles of Himalayan Gold country Spirit 60.up containing @ 600 ml. under proper seizure list (which is enclosed herewith) to the effect that on 20.05.2021 at 16:05 hrs during my special mobile van duty received an information that one Vishal Sah is storage selling liquor in his hotel Styled as "Bhai Bhai Hotel", without any valid license. Informed the matter to I/C Pradhannagar PS over cell phone and as per instruction myself along with force had been to the spot to verify the veracity of information vide GDE No-1027. On reaching at the spot at 16:20 hrs it was found that one person above noted was selling liquor at the said place/ hotel to his customer. On being seen the police party the common customer as well as seller tried to fled away but the seller was apprehended above noted. Then I searched the Hotel and recovered 1. 10 (ten) bottles of King Fisher Strong Premium Beer containing @ 650 Ml. 2. 14 (Fourteen) bottles of Himalayan Gold country Spirit containing @ 600 ml from inside the Hotel. On being asked the said persons failed to produce any document or license for selling liquor at that place. I seized the same duly signed by the witnesses. Seizure was made in between 16:40 to 17:10 hrs). I then arrested the accused person namely Vishal Sah (M-18) S/o Late- Radha Sah of Darjeeling More, PS Prdhan Nagar, Dist-Darjeeling after preparing memo of arrest and intimating the ground of arrest.

Therefore, I request you to start a specific case law against the arrested persons namely Vishal Sah (M-18) S/o Late- Radha Sah of Darjeeling More, Ps Prdhan Nagar, Dist-Darjeeling as per law and arrange for its investigation.
