I, Suman Sengupta, son of Ashoke Sengupta, Divisional Engineer & Station Manager, Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India, would like to lodge a complaint regarding damage of electric lines and property of WBSEDCL. At around 21:20 hrs on 21.05.2021 night Power House Customer Care Centre received information regarding damage of electric lines in Lower Bhanunagar, Near Nirman Vidyajyoti School, P.S. – Bhaktinagar, Dist – Jalpaiguri. On reaching the site the maintenance van of Power House Customer Care Centre found that, one truck having Vehicle No. – NL-01 N2651, had broken 2 nos. 8 mtr. PCC Pole along with LTOH line and caused other damages to the Electric lines which are the property of WBSEDCL. The total damages caused by the vehicle are approximately around Rs. 23377/- (Twenty Three Thousand, Three Hundred and Seventy Seven Rupees only).

Thus you are requested to kindly initiate an investigation against vehicle no. – NL-01 N2651 under Section 139 of the Electricity Act 2003 amended on 2007 of India.
