They all are violated the order of Govt. of West Bengal vide Memo No. 486-CS/2021 dt. 24.04.2021. Hence, I arrested them in c/w the case under proper memo of arrest in between 15:25 hrs to 16:15 hrs. duly signed by them in presence of witnesses inform the ground of arrest.

Now, I request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation of the case.
