Sir,

With due respect and producing herewith the arrested accused persons namely (i) Jitendar Singh (32 yrs) S/O Kallu Singh and (ii) Sonu Kumar (23 yrs) S/O Mahabir Singh both of Vill- Sherpur, PO- Dharampur, PS- Dharampur, Dist.- Bijnor, Bihar under arrest and the following articles under seizure :-

1. One truck displaying number plate UP/32/CZ/2177 .
2. 499 (Four hundred ninety nine) numbers of paper made cartoon each cartoon containing 48 bottles of "Mc Dowell's No1 LUXURY Premium Whisky i.e. total 23,952 bottles of "Mc Dowell's No1 LUXURY Premium Whisky containing 180 Ml in each bottle of Rs 50.00 of each bottle i.e total of Rs 11,97,600/- (Eleven lakhs ninety seven thousand six hundred only)
3. 148 (One hundred forty eight) numbers of paper made cartoon each cartoon containing 24 bottles of "Mc Dowell's No1 LUXURY Premium Whisky i.e. total 3,552 bottles of "Mc Dowell's No1 LUXURY Premium Whisky containing 375 Ml in each bottle of Rs 100.00 of each bottle i.e total of Rs 3,55,200/- (Three lakhs fifty five thousand two hundred only)
4. 66 (Sixty six) numbers of paper made cartoon each cartoon containing 12 bottles of "Mc Dowell's No1 LUXURY Premium Whisky i.e. total 792 bottles of "Mc Dowell's No1 LUXURY Premium Whisky containing 750 Ml in each bottle of Rs 200.00 of each bottle i.e total of Rs 1,58,400/- (One lakh fifty eight thousand four hundred only)

I SI Goutam Mallik of NJP PS, SPC do hereby lodge this complaint against the above noted arrested accused persons that today (19.05.21) at about 18.15 hrs I received a source information that one truck displaying number plate UP/32/CZ/2177 is coming from Meghalaya side towards Bihar which is loaded with huge quantity of illegal I/D liquor. Accordingly, I informed the fact to you and diarised the fact in General diary vide NJP PS GDE No 848 dated 19.05.21 and as per your kind direction myself along with CV/116 Rohit Mahato, CV/306 Biswajit Roy and CV/824 Niru Yadav, VP/13 Jamirul Islam left for Fulbari Toll Gate to verify the veracity of the information in hand. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. In the mean time I called two independent witnesses namely (i) Soumya Bikash @ Bubai Ghosh S/O late Jyoti Prakash @ Mantu Ghosh of Purba Dhantala, PS- NJP, Dist.- Jalpaiguri and (ii) Sukamal Sengupta S/O late Subir Sengupta of Shaktigarh Road No-3, PS- NJP, Dist.- Jalpaiguri and informed them about the information in hand and requested them to remain present with us as witness during the search and seizure if necessary and in which they agreed. At 18.35 hrs we arrived at Fulbari Toll Gate and at 19.05 hrs we managed to intercept the said truck bearing number plate UP/32/CZ/2177 at Fulbari Toll Gate under NJP PS and found two persons inside the drivers cabin. On interrogation they disclosed their identity as noted above. Subsequently, we searched the vehicle and found the above noted I/D liquor loaded in the said vehicle.
