Order in connection with Covid-19 pandemic as declared by the state Govt. of west Bengal vide order no- 647-ISS /2M-22/2020, Dated- 15.05.2021. All the common customers are flew away on seeing the police party. Accordingly I warned the above noted accused to close the shop and to use face mask but he did not pay hid to my words and strongly opposed my lawful direction. Then arrested the owner of the said grocery shop namely Gobind Kumar Gupta, S/O- Panchanan Gupta of Shaktigarh, Lane no 01, PO+PS- Siliguri, Dist- Darjeeling U/S-41 Cr PC. after observing all formalities.

Therefore, I pray before your kind honour that a specific case may kindly started against the accused person namely Gobind Kumar Gupta, S/O- Panchanan Gupta of Shaktigarh, Lane no 01, PO+PS- Siliguri, Dist- Darjeeling under proper section of law and arrange for its investigation.
