In producing herewith 08 (Eight) arrested accused persons who disclosed their identity as (i) Suman Das (25) S/O Ajit Das of Kawakhali Near Primary School PS- Matigara Dist- Darjeeling. (ii) Animesh Sarkar (43) S/o anukul Sarkar of Noukaghat More Ward No 31 PS- NJP Dist- Jalpaiguri (iii) Md Azad (23) S/O Md Nisar of Tikiapara Ward No 28 PS- Siliguri Dist- Darjeeling. (iv) Prashanta Dutta (36) Prabir Dutta of Saktigarh Road No 02 PS- NJP Dist- Jalpaiguri. (v) Tarun Chakraborty (30) S/O Pranab Chakraborty of Shaktigarh near PWD More PS- NJP Dist- Jalpaiguri (Vi) Palash Ch. Sarkar (30) S/O Niren Sarkar of Debidanga Bazar Near Petrolpump PS- Pradhannagar Dist- Darjeeling. (vii) Kartick Debnath(43) s/o Lt Khoch Debnath of Milanpally Ward No 25 PS- Siliguri Dist Darjeeling (viii) Khitish Barman (52) S/Olt Jadhu Barman of 2no Dabgram Near Battalion PS- Njp Dist- Jalpaiguri.

I, SI. Susanta Das of Khalpara TOP under Siliguri PS, SPC do hereby lodge complaint against the above noted arrested persons, to the effect that while on 21.05.21 at 12.05 hrs performing Special mobile van duty myself along with ASI. Uttam Kumar Dhar C 1183 Nikhil Saha, C 1187 Ganesh Sarkar had been to Jhankarmore, Khalpara, Siliguri vide Khalpara TOP GDE No-661 dated 21.05.21 and others and found that the above noted persons and others made unnecessary gathering at the public places without wearing mask. On being asked the above noted persons stated that they were well aware of the COVID-19 pandemic situation and disobeyed the Govt guidelines without any valid reason.

Hence all of them violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation and to prevent spread of COVID-19 .. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID- 19 throughout the Country. Accordingly I arrested them after issuing proper arrest memo and maintaining health protocols ensure their safety and security.

So, I therefore request you for starting a specific case under proper section of law against the above noted arrested accused persons and arranged proper investigation of the case.
