Sir,

In producing herewith ~~three~~ arrested accused persons named (1) Rajesh Sahani (20) S/O Lt. Sunil Sahani of Rana Busty, Subhashpally, Ward No. 18, PS Siliguri, Darjeeling, (2) Sanjib Das (19) S/O Sambhu Das of Bagrakot, near Uttar Banga Office, Ward No. 20, PS Siliguri, Darjeeling, (3) Rahul Dutta (24) S/O Lt. Dipak Dutta, of Lichu Bagan, Subhashpally, Ward No. 18, PS Siliguri, Darjeeling, along with following seized articles i.e. (i) One knife (big size) measuring 14" including wooden handle recovered from the possession of Rajesh Sahani S/O Lt. Sunil Sahani (ii) One iron made Hasua (sharp cutting weapon) measuring 26" including wooden handle recovered from the possession of Sanjib Das S/O Sambhu Das (iii) One iron rod measuring 22", (one side pointed) recovered from the possession of Rahul Dutta S/O Lt. Dipak Dutta which he was holding on his hand (iv) One three Cells torch light under proper seizure list.

I, SI Ashim Kumar Das of Panitanki TOP under Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint to the effect that on 22.05.21 at 00:55 hrs I received secret source information that 8/9 persons have assemble in a dark place near Army parking open field, beside Sevoke road with a view to commit dacoity at the locality. Immediately I informed the tip of information to OC Panitanki TOP as well as I/C Siliguri PS and as per their kind direction, I diarized the fact in GD book vide Panitanki TOP GDE No. 470 Dated 22.05.2021. Accordingly myself along with ASI Mantu Dey, ASI Gopesh Ch Barman, ASI Biswajit Ghosh, C/153 Santosh Mahato, C/370 Bharat Ch. Roy, C/1036 Gopal Sribastav, CV/1007 Jiten Roy left for PO to verify the veracity of the information. This refers Panitanki TOP GDE No. 471 dated 22/05/21. At about 01:15 hrs I along with above noted police party arrived at the spot near a dark place near Army parking open field, Sevoke road and after keeping our vehicle at a distant place we proceeded towards Army parking open field on foot and being indicated by the source we noticed from the considerable distance that a gang of 8/9 persons have been assemble behind the dark place near Army parking open field, sevoke road and they were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of Police party, they scattered in multi direction and started fleeing away but after a hot chase we manage to apprehended 03 (Three) persons named (1) Rajesh Sahani S/O Lt. Sunil Sahani (2) Sanjib Das S/O Sambhu Das (3) Rahul Dutta S/O Lt. Dipak Dutta. On interrogation, the apprehended persons disclosed their identity as noted above, and started giving incoherent statement regarding their presence/gathering in the same place also. On further grilling they stated that they along with others were assembled there in preparation to commit dacoity. Accordingly, I managed to call two independent witnesses on the spot and on being search in presence of the independent witnesses recovered from the apprehended persons the following articles i.e. (i) One knife (big size) measuring 14" including wooden handle recovered from the possession of Rajesh Sahani S/O Lt. Sunil Sahani (ii) One iron made Hasua (sharp cutting weapon) measuring 26" including wooden handle recovered from the possession of Sanjib Das S/O Sambhu Das (iii) One iron rod measuring 22", (one side pointed) recovered from the possession of Rahul Dutta S/O Lt. Dipak Dutta which he was holding on his hand (iv) One three Cells torch light. Accordingly, I seized the above noted recovered articles as per seizure list in presence of witnesses and duly signed by them. The seizure was made in between 01:45 hrs to 02:15 hrs and I arrested them U/S 41 Cr.P.C after explaining the charges against them.

Under the above fact and circumstances I pray that a specific case may kindly be started against (1) Rajesh Sahani (20) S/O Lt. Sunil Sahani of Rana Busty, Subhashpally, Ward No. 18, PS Siliguri, Darjeeling, (2) Sanjib Das (19) S/O Sambhu Das of Bagrakot, near Uttar Banga Office, Ward No. 20, PS Siliguri, Darjeeling, (3) Rahul Dutta (24) S/O Lt. Dipak Dutta, of Lichu Bagan, Subhashpally, Ward No. 18, PS Siliguri, Darjeeling along with seized articles as mentioned above under proper section of law.
