Sir,

In producing here with the arrested accused person namely Santosh Das-40yrs s/o Lt Madan Das of Nepali Patty, Ganganagar, ward No-V, PS Siliguri Dist: Darjeeling along with seized (i) 63 (sixty three) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 110/-in each bottle i.e. total amount of Rs- 6930/- (Six thousand nine hundred thirty) in which 02 (Two) bottles are taken as sample and marked as Exhibit- "A-1" from mother packet Exhibit-A.

I beg to report that today i.e. 22.05.21 at about 22.15hrs received source information that one person namely Santosh Das of Ganganagar is selling huge alcohol at his house at Nepaly patty, Ganganagar, Ward No-V of SMC under Siliguri PS without any valid license and documents in higher price than the actual value for his illegal gain also violating Govt of West Bengal order against COVID-19.

Accordingly I informed the fact to I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for Nepaly patty, Ganganagar under Siliguri PS to verify the veracity of the information and also inform night Van officer ASI Sanjay Hasda & Force to present the spot vide Khalpara TOP GDE No - 725 Dated: 22.05.21. After reaching the PO at 22.25 hrs and as shown by the source I found the above noted person is selling liquor secretly to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept him. On being asked he disclosed his identity as mentioned above. During search, I could recover the above noted alcohol kept hidden in a gunny bag beside high drain. During interrogation he admitted that he is selling alcohol for his wrongful gain. On demand he failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since long after violating the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no **-486-CS/2021 dated 24.04.21** arising out of order No- **79-CS/2020 dated 12.04.2020** & Order No-**647-1SS/2M-22/2020 dated 15.05.21** to prevent spread of COVID-19 . The above noted person has intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID-19 throughout the Country.

Accordingly, I seized the above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused

person U/S- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 22.30hrs to 23.10hrs on 22.05.21.

Under the above noted fact and circumstances, I therefore, pray that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Santosh Das-40yrs s/o Lt Madan Das of Nepali Patti, Ganganagar, ward No-V, PS Siliguri Dist: Darjeeling for the possessing and selling alcohol illegally after violating Govt order and arrange for its investigation.
