Sir,

I S.I Kamal Kumar Roy of Pradhannagar PS, SPC do hereby lodged a written complain against one Anand Kumar Gupta @ Sonu, s/o- Lt. Rabindra Prasad Gupta of Near Dhup Company Road, PS- Pradhannagar, Dist- Darjeeling to the effect that as per memo vide no- 1829/ACP(W)/SMP Dt 20.05.21 and as per endorsement by I/C Pradhannagar PS, SPC over the complaint to the residents of Singalila Park, Hill Cart Road under Pradhannagar PS I had been to the land between Durga Hyundai and Singalila Park and on enquiry it came to learnt that the owner of the above land is one Anand Kumar Gupta @ Sonu, s/o- Lt. Rabindra Prasad Gupta of Near Dhup Company Road, PS- Pradhannagar, Dist- Darjeeling. On 16.05.21 morning at about 05.00 hrs during lock down he set up a fish market without any permission from the appropriate authority at the alleged land where sellers had gathered violating the lockdown guidelines which has already been promulgated nationwide in order to combating the spread of COVID -19 vide Govt of West- Bengal order No 647-ISS/2M-22/2020 dated 15.05.2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3<sup>rd</sup> June ,2020 and Memo No 486-CS/2021 dated 24<sup>th</sup> April , 2021. Thus he violated the said order.

Hence I would therefore request you to kindly start a specific case u/s 188/269 IPC R/W section 51 (b) of disaster management act 2005 against the accused namely Anand Kumar Gupta @ Sonu, s/o- Lt. Rabindra Prasad Gupta of Near Dhup Company Road, PS- Pradhannagar, Dist- Darjeeling and arrange for its investigation.
