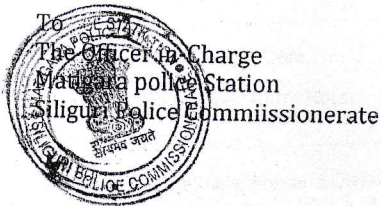

Jamir (22), S/O Jamil Khatoon of Hospital More, P.S - Matigara, Dist - Darjeeling arrested u/s 41 Cr.P.C.

I, S.I. Jamir (22), S/O Jamil Khatoon of Hospital More, P.S - Matigara, Dist - Darjeeling to the effect that today on 24.05.2021 at 13:55 hrs myself along with force while performing lock down duty at Matigara Bazar under Matigara P.S area found that above noted accused persons were loitering at above noted area without wearing any face mask and without any rhyme and reason which is amounting to Non-Compliance of Govt. Order in c/w Covid-19 pandemic as declared by the State Govt. by the State Government vide No. 647-ISS/2M-22/2020, dated - 15.05.2020. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Therefore, I pray before your kind honour that a specific case may kindly be started against the accused persons (i) Sanjit Paswan (32), S/O jaishre Paswan of Rail gate, Biswas Colony, P.S - Matigara, Dist - Darjeeling, (ii) Kudrat Khan (30), S/O Saqir Khan of Rail gate, Biswas Colony, P.S - MTG, Dist - DJG, (iii) Afjal Alam (22), S/O Noor Alam of Hospital More, P.S - Matigara, Dist - Darjeeling, (iv) Md. Jamir (22), S/O Jamil Khatoon of Hospital More, P.S - Matigara, Dist - Darjeeling under proper section of law and arrange for its investigation.
