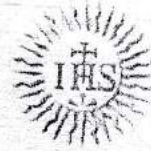

**Subject: FIR regarding SEVERAL times THEFTS and Property DESTRUCTION in Jesu Niketan School, Matigara.**

Sir,

Criminals cutting barbed and concertina wires, breaking locks, stealing essential household items and cruelly snatching away electrical wirings are on PROWL.

Yesterday some THIEVED and DESTROYED Jesu Niketan School property. Our ELECTRICAL Connections were destroyed YET AGAIN and broke open LOCKS to steal essential School things. We have been experiencing a SERIES of THIEVING and DESTRUCTION.

Regarding such thefts, we had LODGED with you an FIR in on April 29<sup>th</sup>. The lost things were:

- Aluminium Buckets – 3 pieces
- Aluminium Degchis – 3 pieces
- Aluminium Degchi lids – 3 pieces
- Aluminium Big Degchi lid – 1 piece
- Steel Ladle – 1 piece
- Kettle – 1 piece
- Frying Pan – 1 piece
- Sauce Pan – 1 piece
- Edible Oil – 4 Packets

They cut BARBED wire and CONCERTINA wire and broke iron ANLES of fence to make entry. The next day Electrical wiring was stolen and switchboards, holders and connection to the electrical meter and electrical cut-outs for the ENTIRE School were destroyed. Due to such more criminal activities when we presented a **Second FIR** on April 30<sup>th</sup>, we were ASSURED that one single FIR would suffice.
