Sir,

In producing herewith 04 (Four) arrested persons namely (i) Kartick Mali-55yrs s/o Lt Gopal Mali of Haiderpara near Sonali Bhawan PS Bhaktinagar Dist Jalpaiguri (ii) Mithun Sahani-33yrs s/o Lt Ram Bahadur Sahani of Subhashpally, Rana busty, ward no-18, PS Siliguri Dist Darjeeling (iii) Mahesh Sahani-21yrs s/o Ram Sebak Sahani of Bagrakote, ward no-18 PS Siliguri Dist Darjeeling (iv) Biswajit Basak-29yrs s/o Lt Rajen Basak of Jyotinagar ward No-04, PS Siliguri Dist Darjeeling along with all connecting paper.

I, SI Srimanta Chatterjee of Khalpara TOP under Siliguri PS, SPC do hereby lodge complaint against the above noted arrested persons, to the effect that while on performing Special mobile van duty myself along with ASI Aminul Islam, ASI Uttam Dhar, C/490 Gopal Mahato and CVF/980 Ranjan Ojha all of Khalpara TOP-II under Siliguri PS had been to Jhankar More, Siliguri at about 12 AM (Khalpara TOP GDE No- 740 dated 23.05.21) and found that the above noted persons had made unnecessary gathering at the public places without wearing mask. On being asked the above noted persons stated that they were well aware of the COVID-19 pandemic situation and disobeyed the Govt guidelines without any valid reason.

Hence all of them violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, & order No-629-1SS/2M-22/2020 dated 05.05.21 & Order No-647-1SS/2M-22/2020 dated 15.05.21 that wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation and to prevent spread of COVID-19. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID- 19 throughout the Country. Accordingly I arrested them after issuing proper arrest memo and maintaining health protocols ensure their safety and security.

So, I therefore request you for starting a specific case under proper section of law against the above noted arrested accused persons namely (i) Kartick Mali-55yrs s/o Lt Gopal Mali of Haiderpara near Sonali Bhawan PS Bhaktinagar Dist Jalpaiguri (ii) Mithun Sahani-33yrs s/o Lt Ram Bahadur Sahani of Subhashpally, Rana busty, ward no-18, PS Siliguri Dist Darjeeling (iii) Mahesh Sahani-21yrs s/o Ram Sebak Sahani of Bagrakote, ward no-18 PS Siliguri Dist Darjeeling (iv) Biswajit Basak-29yrs s/o Lt Rajen Basak of Jyotinagar ward No-04, PS Siliguri Dist Darjeeling and arranged proper investigation of the case.
