They all also violated the order of Govt. of India duly promulgated in order no 40-3/2020-DM-I (A), Govt. of India Ministry of Home Affairs Dated 24.03.2020 and MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV Dt. 27/04/20 & Govt. of WB order No - 79-CS/2020 Dated- 12.04.2020 and advisory issued vide no- 715-Home 9Cons)/RIM (Cons)-92/2021 Dated- 17.04.2021 and Memo No- 486-CS/2021 Dated- 24.04.2021 and Order No 647/ISS/2M-22/2020, dated 15.05.2021, The above noted persons have intentionally refused to comply with the order of Govt. of India and Govt. of West Bengal duly promulgated in view of break- out of Pandemic COVID- 19 throughout the Country. Finding no any other alternative I arrested them u/s 41 Cr.p.C under proper memo of arrest after explaining the charge against them.
