SUB:- F.I.R. against my husband, parents-in-law i.e. Mother-in-law and Father-in-law members for committing physical and mental torture upon me due to demand of dowry and also for attempting to kill me due to non-fulfillment of the demand of dowry.

Respected Sir/Madam,

With due regards, I, Smt Sushmita Ghosh (Roy), D/O Sri Jiban Roy, W/O Sri Koushik Ghosh, at present residing at "Shee Ma Bhawan, Haiderpara, P.O. & P.S. Bhaktinagar, Dist- Jalpaiguri, West Bengal, would like to lodge this written complaint to the following effects:

1. That my marriage was solemnized on 22.01.2019, with Sri Koushik Ghosh, S/O Sri Pratap Ghosh, residing at Near Ram Thakur Mandir, Ghosh Bhandar, Millanpally, P.O. & P.S. NJP, Dist- Jalpaiguri, according to the provision of Special Marriage Act being serial No. 65/2018 dated 17.12.2018. It is to be mentioned here that the said marriage is an out-come of previous love & affair.
2. That at the time of my marriage, my parents and other nearest relatives had given so many valuable articles including cash of a sum of Rs. 2,00,000/- only and other household articles for my better future life as per demand of my husband, my mother-in-law and my father-in-law.
3. That after my marriage, I along with my husband, lived and co-habited together as husband and wife in my matrimonial house situated at Near Ram Thakur Mandir, Ghosh Bhandar, Millanpally, P.O. & P.S. NJP, Dist- Jalpaiguri and out of our lawful wed-lock, I gave birth of one male child on 05.08.2020, whose name is Master Saatvik Ghosh.
4. That Just after few days of our marriage, my husband, my mother-in-law and father-in-law have started physical and mental torture upon me on the demand of more dowry and when I refused to bring any money from my parents, my husband along with his mother and father have started torture upon me both physically and mentally on a false and fabricated allegations. My husband is a suspicious character and he

always created doubt upon me suppose if any of my male relative came to my house, he started torture upon me by saying that I have a relation with my said relative and due to his said torture, I became mentally traumatize and ill. On some occasions, when I oppose against his said illegal acts and behaviour, he tried to kill me by pouring kerosene oil on my person and sometimes, tried to kill me by pushing pillow on my mouth.

5. That I narrated the same to my mother who tried to intervene into the matter and requested my husband to behave properly with me but he did not pay any heed to the said request of my mother. Day by day, the torture of my husband, mother-in-law and father-in-law have increased and my husband always insisted and encourage me to bring money from my parents and when I refused to do the same, he did not bother to assault me physically and mentally.
6. That my husband is a habitual drunker and he used to come at home in late hours with a fully drunken condition and started torture upon me and when I started to raise objection against his said habit, then he started to misbehave with me and also started to use filthy and offensive languages upon me on giving blaming upon me of maintaining such illicit relationship with another person.
7. That soon after my marriage, I found that my husband and my parents-in-law namely (1) **Shila Ghosh (mother-in-law), W/O Sri Pratap Ghosh** and (2) **Pratap Ghosh, S/O Not Known (father-in-law)**, all are resided at Near Ram Thakur Mandir, Ghosh Bhandar, Millanpally, P.O. & P.S. NJP, Dist- Jalpaiguri, have started criticizing me and also showed their dissatisfaction over the articles of jewelery and other articles which were given to me at the time of my marriage and also started taunting me.
8. That my husband and my parents-in-law have started torture upon me on various ways. They have given some guidelines upon me and created pressure to obey all and each guidelines as per their instruction such as not to use Shampoo at the time of bath, to use

Comod for urinal, not to use toilet more than once, complete the lunch within 01.00 P.M otherwise no food will be supplied., not to use or see T.V., not to use fan etc. They have also denied to permit me to go outside from the house and also restricted me to call or talk with my mother and other relatives over phone. My mother-in-law Smt. Shila Ghosh, used to assault me physically very often if any violation of their guidelines is occurred from my side. My mother-in-law never accepted me as her daughter-in-law and she never allow me to do any work of my choice in my matrimonial house. I have disclosed the aforesaid torture of my mother-in-law to my husband, but my husband never made any protest and inspite of asking his mother not to behave in such a manner with me, he threatened me with dire consequences by saying that if I failed to follow and obey the aforesaid direction of his mother, it is not possible for him to continue and maintain the conjugal life with me and he also threatened me not to disclosed the same to anybody and on being protest by me, he tried to kill me by pushing pillow on my mouth.

9. That subsequently, I came to learn that my husband had/has a illicit relationship with various woman and after coming home from his office he used to remain busy with phone calls, whatsapp, facebook and when I asked about the said illicit relationship of my husband, my husband used to abused me with filthy and offensive languages and my husband started to create tremendous mental and physicals torture upon me. He used to beat me with fists and blows and also by kicks. Sometimes, he used to assault me by catching my hair logs.
10. That thereafter, my husband and my parents-in-law in conspiracy with each other have started tremendous physical and mental torture upon me with a view to bring a sum of Rs. 3,00,000/- (Rupees Three Lacs) only from my parents. I have made several request to them that my parents have already given huge money as and when they demand and it would not be possible for them to fulfill their said demand and after hearing the same from me, they have increased their torture upon

me both physically and mentally. They have stopped to provide me sufficient food and they have adopted some illegal means with a view to harm me and also provoked and abate me to commit suicide by using and uttering some slang and offensive languages like "TOR MOTON MAYE DER EI PRITHIBITE BECHE THAKAR KONO ADHIKAR NEI, TUI MORTE PARIS NA, TUI MORLE, AMRA ABAR AMADER CHELE KE ANNO JAYGAY BIYE DEBO AAR ONEK TAKA PABO" and due to their aforesaid torture and ill-behaviour, I became ill and during my serious illness, neither they took me to the doctor nor they have taken any care upon me.

11. That one day my mother-in-law in conspiracy with my husband and other in-laws members, have kept open the knob of gas oven and ordered me to prepare food for them and when I reached in the kitchen, they tried to make fire with the help of a fire box and on getting smell of L.P. gas and realizing their motive and intention, I fled away from the kitchen room and somehow, I rescued my life from their hands and, thereafter, I narrated the aforesaid incident to my parents and other relatives and due to their interference, sometimes, they have stopped their torture upon me.
12. That when my child is one month my husband, mother-in-law and father-in-law forcefully thrown out me from my matrimonial house and finding no other alternative I took shelter to my parent's house.
13. That subsequently after lapse of few day my husband came to my parents house and apologies for his misdeed and convince me that he will take a house on rent and we should start our life freshly and accordingly my husband took a house on rent at Shee Ma Bhawan, Haidepara, P.O. & P.S. Bhaktinagar, Dist- Jalpaiguri and we started our respective life freshly but after lapse of few days my husband again started to torture me with full of drunken condition and also used to maintain illicit relationship with other girls.

14. That it is further to be mentioned here that the first wife of my husband namely "Puja" committed suicide due to provoke of my husband, mother-in-law and father-in-law and the said his case till pending at Siliguri Court.

15. That I have passed my marital life with my husband and in-laws members with so many miseries, torture, assault and they have become my life with so many miseries and they have increased their torture upon me and they treated me just like a maid servant and I used to bear such type of inhuman torture of my husband and other in-laws members with a hope that everything would be settled in near future but they did not stopped their said inhuman torture. Moreover, they have started to increase the parameter of their mental and physical torture upon me day by day and thereby, they have spoiled my life completely.

I, therefore, requesting you to investigate in to the matter and please take necessary legal steps against my husband and other in-laws members as per the provision of law and obliged thereby.
