In producing herewith seven (07) arrested accused persons who disclosed their name & identity as
(i) Samir Ghosh (33yrs) S/O- Narayan Ghosh of Bharatnagar, Ward No-24, PS-Siliguri, Dist-Darjeeling,
(ii) Gopal Barman (37 yrs) S/O- Lt. Sudhir Barman of Santipara, Fulbari-I GP, PS-NJP, Dist-Jalpaiguri,
(iii) Shyamal Shil (49 yrs) S/O- Sumanta Shil of 2 No. Jyotinagar Colony, Ward No-4, PS-Siliguri, Dist-Darjeeling, (iv) Pankaj Ghosh (35 yrs) S/O- Lt. Jiten Ghosh of Bhaktinagar, near Central Bank, PS-NJP, Dist-Jalpaiguri, (v) Binay Sarkar (47 yrs) S/O- Charan Sarkar of Lichubagan, Subashpally, PS-Siliguri, Dist-Darjeeling, (vi) Ujjal Halder (42 yrs) S/O- Lt. Gobin Halder of Santipara, Fulbari-I GP, PS-NJP, Dist-Jalpaiguri & (vii) Debasish Sarkar (24 yrs) S/O- Santosh Sarkar of Haripur, near Army Camp, PS-NJP, Dist-Jalpaiguri alongwith their vehicles bearing Reg Nos. Viz- (i) one Scooty ash colour bearing Reg No- WB 74AT/1400, (ii) Toto rickshaw gray colour bearing No- WB 73F/1971, (iii) Toto rickshaw red colour bearing No- SMC-TO-2856, (iv) Toto rickshaw green colour without number, (v) Toto rickshaw green colour without number & (vi) Toto rickshaw blue colour bearing No- T/C WB71-TC/1007. I, SI Mihir Majumder of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 24.05.2021 at 10.55 hrs during my R/T Mobile Van duty had been to Thana More Babupara area, Siliguri and found the above noted persons were moving/ gathered alongwith their vehicles noted above without wearing mask on their face and without any valid reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of India duly promulgated in order No. 40-3/2020-DM-1(A), Govt. of India Ministry of Home affairs dated 24.03.2020 & MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV dated 27.04.2020 and Govt. of West Bengal order no- 134-Pr. Sec (Tr) dated 04.06.2020 & Order no- 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of India duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
