In producing herewith seven (07) arrested accused persons who disclosed their name & identity as (i) Ratan Roy (40 yrs) S/O- Lt. Ramesh Roy of Gate Bazar, near Allu Godown, PS-NJP, Dist-Jalpaiguri, (ii) Tapash Paul (25yrs) S/O- Dilip Paul of Chayanpara, Ghugumali, PS-Bhaktinagar, Dist-Jalpaiguri, (iii) Gobinda Biswa Sharma (30 yrs) S/O- Gouranga Biswa Sharma of Thakur Nagar near Club Math, PS-NJP, Dist-Jalpaiguri, (iv) Pintu Mallick (28 yrs) S/O- Nitai Mallick of Purba Hatiyadanga, near Bazar, PS-Bhaktinagar, Dist-Jalpaiguri, (v) Deepak Barman (27 yrs) S/O- Rathin Barman of Fulbari, Sepaipara, PS-NJP, Dist-Jalpaiguri, (vi) Bablu Thakur (50 yrs) S/O- Bharat Thakur of Champasari Anchal, PS-Pradhannagar, Dist-Darjeeling & (vii) Uttam Das (38 yrs) S/O- Bijay Das of Thiknikata, near Kali Mandir, PS-Matigara, Dist-Darjeeling alongwith their vehicles bearing Reg Nos. Viz- (i) Toto Rickshaw blue colour bearing No- WB 73F/3992, (ii) Toto rickshaw red colour bearing No- WB73F/6510, (iii) Toto rickshaw light green colour bearing No-WB73F/1654, (iv) Toto rickshaw black colour without number, (v) Toto rickshaw red colour without number & (vi) Toto rickshaw green colour. I, SI Uttam Kr. Ghosh of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 24.05.2021 at 12.50 hrs during my R/T Mobile Van duty had been to Venus More area, Siliguri and found the above noted persons were moving/ gathered alongwith their vehicles noted above without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of India duly promulgated in order No. 40-3/2020-DM-1(A), Govt. of India Ministry of Home affairs dated 24.03.2020 & MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV dated 27.04.2020 and Govt. of West Bengal order no- 134-Pr. Sec (Tr) dated 04.06.2020 & Order no- 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of India duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
