In producing herewith eight (08) arrested accused persons who disclosed their name & identity as (i) Subhash Roy (41yrs) S/o- Lt. Puren Roy of Kechagara, PS-Rajganj, Dist-Jalpaiguri, (ii) Suraj Ghosh (32 yrs) S/O- Pranab Ghosh of Shaktigarh, Sitalapara, PS-NJP, Dist-Jalpaiguri, (iii) Om Prokash Mandal (24yrs) S/O- Lt. Ram Shankar Mandal of Gandhi Maidan, Khalpara, PS-Siliguri, Dist-Darjeeling, (iv) Ramdel Mahato (38 yrs) S/O- Lt. Bangli Mahato of Govt. Saw Mill, Ward No-4, PS-Siliguri, Dist-Darjeeling, (v) Rambabu Paswan (30 yrs) S/O- Lt. Ramjote Paswan of Benay Daspally, PS-Matigara, Dist-Darjeeling, (vi) Saroj Sha (24 yrs) S/O- Ganesh Sha of Gandhi Maidan, Khalpara, PS-Siliguri, Dist-Darjeeling, (vii) Bijay Mandal (52 yrs) S/o- Lt. Sudhir Ch. Mandal of Subhashpally, Khudiram Colony, Ward No-18, PS-Siliguri, Dist-Darjeeling, (viii) Smt. Rekha Mandal (F/32 yrs) D/O- Praladh Mandal of Khudirampally, Ward No-18, PS-Siliguri, Dist-Darjeeling. I, SI Subhankar Ghosh of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 24.05.2021 at 17.05 hrs during my R/T Mobile Van duty had been to Venus More area, Siliguri, found the above noted persons were moving/ gathered without wearing mask on their face, without maintaining social distancing and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of India duly promulgated in order No. 40-3/2020-DM-1(A), Govt. of India Ministry of Home affairs dated 24.03.2020 & MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV dated 27.04.2020 and Govt. of West Bengal order no- 134-Pr. Sec (Tr) dated 04.06.2020 & Order no- 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of India duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
