In producing herewith ten (10) arrested accused persons who disclosed their name & identity as (i) Munni Khatun (F/50yrs) W/O- Md. Chheten of NTS More, Ward No-38, PS-Siliguri, Dist-Darjeeling, (ii) Ankit Raj (24 yrs) S/O- Santosh Roy of Deshbandhupara, Ward No-29, PS-Siliguri, Dist-Darjeeling, (iii) Arun Das (49 yrs) S/O- Lt. Bijay Das of Pipeline, Bhaktinagar, PS-NJP, Dist-Jalpaiguri, (iv) Atul Kundu (58 yrs) S/O- Lt. Baidya Nath Kundu of 1 No Dabgram Colony, Udayan Colony, Ward No-23, PS-Siliguri, Dist-Darjeeling, (v) Lakhan Chandra Mandal (54 yrs) S/O- Lt. Surendra Chandra Mandal of Lichu Bagan, Subashpally, PS-Siliguri, Dist-Darjeeling, (vi) Pradip Adhikari (40 yrs) S/O- Lt. Viz- (i) one oven of Aviva & one Cylinder, (ii) one small vehicle white colour bearing Reg No. WB 74AR/0717, (iii) Toto Rickshaw yellow colour without number, (iv) Toto rickshaw dark green colour bearing No- WB73/4676, (v) one black colour city auto bearing No-WB73F/5924, (vi) Toto rickshaw red & white colour bearing No-WB73F/2642. I, SI Subhankar Ghosh of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 24.05.2021 at 17.50 hrs during my R/T Mobile Van duty had been to Tikiapara area and others area under Siliguri PS and found the above noted persons were moving/ gathered alongwith their articles/vehicles noted above without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of India duly promulgated in order No. 40-3/2020-DM-1(A), Govt. of India Ministry of Home affairs dated 24.03.2020 & MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV dated 27.04.2020 and Govt. of West Bengal order no- 134-Pr. Sec (Tr) dated 04.06.2020 & Order no- 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of India duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
