In producing herewith 04 (Four) accused persons namely (1) Janmajoy Karmakar (38) S/O Parikshit Ch. Karmakar, of Vill- Chakvrigu, PO+ PS- Balurghat, Dist- Dakshin Dinajpur. (2) Mir Raju Haque (31) S/O Bablu Hussain of Vill- Dakshin Majhgram, PO- Kranti, PS- Malbazar, Dist- Jalpaiguri. (3) Soumya Chakraborty (38) S/O Subhash Chakraborty of Panchanan Sarani, Ashrampara, Ward No. 14, PS- Siliguri, Dist- Darjeeling. (4) Sankar Kr Roy (71) S/O Lt. Prafulla kr Roy of Rash Behari Sarani, Near Childred Park, Ward No. 17, PS- Siliguri, Dist- Darjeeling under arrest.

I, SI Ashim kr Das of Panitanki Town Out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 24.05.2021 at about 20:15 hrs. while performing Naka duty at Panitanki More area and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as (1) Janmajoy Karmakar (38) S/O Parikshit Ch. Karmakar, of Vill- Chakvrigu, PO+ PS- Balurghat, Dist- Dakshin Dinajpur. (2) Mir Raju Haque (31) S/O Bablu Hussain of Vill- Dakshin Majhgram, PO- Kranti, PS- Malbazar, Dist- Jalpaiguri. (3) Soumya Chakraborty (38) S/O Subhash Chakraborty of Panchanan Sarani, Ashrampara, Ward No. 14, PS- Siliguri, Dist- Darjeeling. (4) Sankar Kr Roy (71) S/O Lt. Prafulla kr Roy of Rash Behari Sarani, Near Childred Park, Ward No. 17, PS- Siliguri, Dist- Darjeeling.

On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and unlock period. Over that some of the local peoples were also annoyed with the accused persons by such an act. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation and unlock period.

Hence, they violated the order of the Govt. of West Bengal duly promulgated in order No. 647- ISS/2M-22/2020 dated 15.05.2021 The above noted person has intentionally refused to comply with the Govt. order duly promulgated in view of break-out of pandemic COVID-19 throughout the State. Accordingly, I arrested the above noted accused persons U/S 41 Cr. P. C.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Janmajoy Karmakar (38) S/O Parikshit Ch. Karmakar, of Vill- Chakvrigu, PO+ PS- Balurghat, Dist- Dakshin Dinajpur. (2) Mir Raju Haque (31) S/O Bablu Hussain of Vill- Dakshin Majhgram, PO- Kranti, PS- Malbazar, Dist- Jalpaiguri. (3) Soumya Chakraborty (38) S/O Subhash Chakraborty of Panchanan Sarani, Ashrampara, Ward No. 14, PS- Siliguri, Dist- Darjeeling. (4) Sankar Kr Roy (71) S/O Lt. Prafulla kr Roy of Rash Behari Sarani, Near Childred Park, Ward No. 17, PS- Siliguri, Dist- Darjeeling and arrange for its investigation.
