Sir,

In producing here with the arrested accused person namely Santa Mahato (55) S/O Lt Arjun Mahato of Govt Saw Mill Road Near Shib Mandir, ward no 04, PS- Siliguri Dist- Darjeeling along with seized (i) 14 (Fourteen) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs- 1400/- (One thousand four hundred) in which 01 (one) bottles are taken as sample and marked as Exhibit- "A-1" from mother packet Exhibit-A.

I beg to report that today i.e. 24.05.21 at about 18.05hrs received source information that one person namely Santa Mahato S/O Lt Arjun Mahato of Adarshanagar Govt Saw Mill Road is selling huge alcohol at his house at Govt Saw mill Road, under Khalpara TOP without any valid license and documents in higher price than the actual value for his illegal gain.

Accordingly I informed the fact to I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for Adarshanagar under Siliguri PS to verify the veracity of the information Van officer ASI Samiran Das & ASI Sanjay Hasda & Force to present the spot vide Khalpara TOP GDE No - 781 Dated: 24.05.21. After reaching the PO at 18.45 hrs and as shown by the source I found the above noted person is selling liquor secretly to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept him. On being asked he disclosed his identity as mentioned above. During search, I could recover the above noted alcohol kept hidden in a gunny bag in his house. During interrogation he admitted that he is selling alcohol for his wrongful gain. On demand he failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since long after violating the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-**CS/2021 dated 24.04.21** arising out of order No- **79-CS/2020 dated 12.04.2020** to prevent spread of COVID-19 .. The above noted person has intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID- 19 throughout the Country.

Accordingly, I seized the above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused person U/S- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 19.15hrs to 19.45hrs on 24.05.21.

Under the above noted fact and circumstances, I therefore, pray that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Santa Mahato (55) S/O Lt Arjun Mahato of Govt Saw Mill Road Near Shib Mandir, ward no 04 PS- Siliguri Dist- Darjeeling for the possessing and selling alcohol illegally after violating Govt order and arrange for its investigation.
