Sir,

In producing here with 05 (Five) arrested accused persons who disclosed their identity as (i) Biswajit Poddar (41) yrs S/O- Anil Poddar of Mahananda Para, Chandra Park, w no- 04, PS Siliguri, Dist- Darjeeling. ii) Dhanesh Prasad (40) yrs S/O- Jogindar Prasad of Gurung Busty, W no- 03, P.S- Pradhan Nagar, Dist. Darjeeling, iii) Sanjoy Kr. Prasad (38) yrs. S/O- Late Baidnath Prasad of Santoshi Nagar, w/no- 05, P.S- Siliguri, Dist. Darjeeling, iv) Ram Dev Prasad (70) S/O- Gujari Prasad of Maharaj Colony, Ward No-5, P.S- Siliguri, Dist- Darjeeling, and v) Arjun Prasad (44) S/O- Lt. Kashi Prasad of Maharaj Colony, W no- 04, P.S- Siliguri, Dist- Darjeeling. all the above noted accused persons arrested proper memo of arrest, in c/w above noted case reference.

I, SI. Upendra Nath Roy of Khalpara TOP under Siliguri PS, SPC do hereby lodge complaint against the above noted arrested persons, to the effect that on 24-05-21 at 1825 hrs, myself along with force while performing Special mobile duty at Maharaj Colony, Siliguri area, Vide Khalpara TOP-II, GDE No-781 dated 24.05.21 and found that the above noted persons had made unnecessary gathering at the public places without wearing mask. On being asked the above noted persons stated that they were well aware of the COVID-19 pandemic situation and disobeyed the Govt guidelines without any valid reason.

Hence all of them violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation and to prevent spread of COVID-19 .. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID- 19 throughout the Country. Accordingly I arrested them after issuing proper arrest memo and maintaining health protocols ensure their safety and security and as per order of I/C Siliguri P.S, and O/C Khalpara TOP-II, I released the above noted accused persons.

So, I therefore request you for starting a specific case under proper section of law against the above noted arrested accused persons and arranged proper investigation of the case.
