Sir,

In producing herewith one (01) accused person namely Dinesh Roy (35), S/O- Lt. Jaleswar Roy of Khalaibakhtari, PO+PS- Matigara, Dist- Darjeeling along with seized articles viz. 20 (twenty) Liters of Raw Spirit I, PSI- Shekhar Adhikary presently posted at Matigara Police Station, Siliguri Police Commissionerate would like to lodge this written complaint against the above noted person to the effect that today (25.05.2021) at 14.45 hrs while performing Special Mobile duty, myself along with ASI- Subhendu Das, ASI - Nitai Mandal C/1035 Santosh Rabidas, CV/155 Sukumar Das and CV/387 Sukumar Barman had been to Khalaibakhtari area received secret source information that the above noted person has stored Raw Spirit at his house. Then I cordoned the house with my accompanied force and detained the person who on being asked disclosed his identity as noted above and stated that he is the owner of the house. On being search of his house in presence of available witnesses the above noted seized article is found inside his house. On being asked he failed to produce any valid license/papers for storing of such article. Then I seized the above mentioned article under proper seizure list in presence of witnesses whose signature have also been taken in the seizure list and subsequently arrested the above mentioned person. On further interrogation of the arrested person it could be learnt that he is involved in selling and possessing the Raw Spirit without any valid license for his illegal gain. The seizure has been made in between 15.05 hrs to 15.30 hrs.

Therefore I pray before your good self that a specific case against the above noted accused person namely Dinesh Roy (35), S/O- Lt. Jaleswar Roy of Khalaibakhtari, PO+PS- Matigara, Dist- Darjeeling may kindly be initiated under proper section of law and may cause for its investigation.
