entered into our office nursing home  
and used to hurt valqur languages towards  
us and also told me they came here to  
take medical papers of some patients but we  
noticed that some unknown person are  
outside of the nursing home, the above  
said person serial no 1, 2, 3 are trying to  
remove the medical equipment from the  
nursing premises under the instruction of  
the above said serial no. 4, 5, 6 because

said serial no 4, 5, 6 are the  
lessee / tenant our us and they did not  
render any rent since the inception of  
the <sup>our</sup> nursing home as a lessee. Presently  
they are trying to escape from our nursing  
home without render <sup>any</sup> rent ~~for~~ near about  
6 or 7 month approx Rs. 500000/- Fitty lakhs  
while we want to resist them then the  
above said person namely Tomoy Bhowmick  
pushed me with inten ~~to~~ outrage the  
modesty of me.

In view of above you are requested to  
look into the matter and take proper legal  
steps against them as per law.
