
I PSI Sumit Sarkar of Pradhan Nagar Police Station under Siuliguri Police Commissionerate do here by lodge this written complaint to the effect that today i.e 25.05.2021 in between 11.15 hrs. to 13:05 hrs myself along with SI Samik Paul, ASI Ratan Pradhan, ASI Debasish Das, Const- 207 Niladri Sarkar and other of Pradhannagar Police Station had been to Champassari more area, PS- Pradhan nagar, Darjeeling and found the above noted persons were loitering with any rhyme and reason and some persons were open their Grocery shop, Sallon, fruit shop beyond time bound period which was promulgated by Govt of West Bengal.

On being asked the above noted persons stated before me that they had well to aware of the pandemic situation and they supposed to remain in home and not to come out without any reason. Hence , they violated the order for combating the spread of COVID- 19 as per order of Govt of West- Bengal vide order No 647- ISS/2M-22/2020 dated 15.05.2021 and Notification number 347 -01.S.S / 2M- 24/2020 dated 3rd June ,2020 and Memo No 486-CS/2021 dated 24th April , 2021 in view of break-out of pandemic COVID-19 throughout the country as well as State.

Accordingly, I arrested them u/s 41 CR.P.C in c/w the above case. Hence, I request you for starting a specific case u/s 188/269 IPC R/W Sec 51 (b) Disaster Management Act, 2005 against the above noted arrested persons and arranged to proper investigation of the case.
