In producing herewith six (06) arrested accused persons who disclosed their name & identity as (i) Tapash Biswas (34yrs) S/O- Lt. Sadananda Biswas of New Township, Medical More, PS-Matigara, Dist-Darjeeling, (ii) Atul Singh (20yrs) S/o- Pappu Singh of Mallaguri, near Hotel Cloud Nine, Ward No-46, PS-Pradhan Nagar, Dist-Darjeeling, (iii) Rahul Gupta (28yrs) S/O- Bijay Kr gupta of Khalpara, near Ration Step, Ward No-8, PS-Siliguri, Dist-Darjeeling, (iv) Adhir Roy (40yrs) S/O- Lt. Khi Mohan Roy of Sraban Nagar, Bagrakote, Ward No-18, PS-Siliguri, Dist-Darjeeling, (v) Madhab Ch. Roy (54yrs) S/O- Lt. Jadu Nath Roy of Rajaram Mohan Colony, near FCI Godown, Ward No-20, PS-Siliguri, Dist-Darjeeling, (vi) Jogesh Barman (52yrs) S/O- Lt. Nagendra Nath Barman of Shib Mandir, Indirapally, PS-Matigara, Dist-Darjeeling alongwith their vehicles bearing Reg Nos. Viz.- (i) Toto light green colour without number & (ii) Toto rickshaw red colour bearing No- WB 73F/7818. I, SI Gopal Chandra Mandal of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 25.05.2021 at 11.05 hrs during my R/T Mobile Van duty had been to Mahabirsthan area under Siliguri PS and found the above noted persons were moving/ gathered alongwith their respective vehicles noted above without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of India duly promulgated in order No. 40-3/2020-DM-1(A), Govt. of India Ministry of Home affairs dated 24.03.2020 & MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV dated 27.04.2020 and Govt. of West Bengal order no- 134-Pr. Sec (Tr) dated 04.06.2020 & Order no- 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of India duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.


