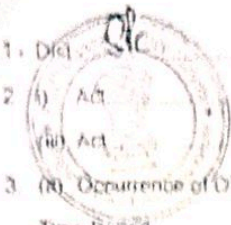

Dear Sir,

This is to inform you that on 24/05/2021, my husband Milan ~~Sarkar~~ was referred to Siliguri due to lack of ICU in Daxiceling. We immediately drove him to North Bengal Neuro hospital, and got him admitted and on same evening we were informed that patient was suffering from Covid positive and lungs infection so the treatment had started. Up to this point we have been fairly satisfied with the treatment as per told to us and till date 25/05/2021 we have already paid (90,000) Ninety thousand. Yesterday dated 25/05/2021 I met with the doctor who was treating my husband and discussed about the condition he then asked for the test report of RTPCR to the management they were not able to give us the RTPCR report. Whereas the doctor had already written RTPCR test to be done on 22/05/2021 in his report. We are shocked and disbelief that the hospital management would neglect specially at this time of Pandemic.
