Dear Sir,

With due respect I the undersigned would like to inform you that Sri Nirmal Ghosh, S/o. Rabindranath Ghosh, resident of Basantapur, Howrah, P.O. & P.S. Amta, Dist. Howrah and presently residing at A.P.C. Sarani bylane, Shibram Pally, Haider Para, Siliguri, P.O. – Rabindra Sarani, P.S. – Bhaktinagar, Dist. Jalpaiguri, had entered into the marriage with me and our marriage was solemnized in the year of 2002 according to Hindu Rites and Customs. That after marriage I was brought by my husband at his rented house situated at Shibram Pally, Haider Para, Siliguri, P.O. – Rabindra Sarani, P.S. – Bhaktinagar, Dist. Jalpaiguri where we began our conjugal life. That out of our said wedlock, I gave birth of a female child on 17/07/2004 namely Rina Ghosh and also gave birth of a male child on 01/11/2007 namely Nil Ghosh. That since the date of our said marriage, my husband used to misbehave with me just without reasonable cause and on several occasions he used to return home almost every day late night in intoxicated condition and whenever I tried to convince my husband to stop the consumption of alcohol, he used to assault me mercilessly. I being the responsible wife and mother having two children used to swallow all the torture for the future of the said children and with a hope for better conjugal life.

I would like to further inform you that after birth of my daughter my husband used to put pressure upon me to bring money from my parents regularly and when I refused his said illegal demand, my husband use to accelerate his quantum of torture upon me.

That in the year of 2020, my husband put pressure upon me to bring a sum of Rs.30,00,000/- (Rupees Thirty Lac) only from my father as because he wanted

to purchase a new residential accommodation and start a new business and on refusal, my husband started to misbehave with me and use to inflict physical torture upon me and same increased day by day and my husband also use to character assassinate me on false allegation. That on 18/02/2020 at about 8.30 pm my husband came home and he was in a rage against me for reasons best known to him and he ordered me to prepare tea and while I was boiling water for the same he grabbed me from behind and poured hot boiling water on my face and I had to undergo treatment for the same. That my husband used to without any reasonable cause assault me brutally on any flimsy ground or without any pretext whatsoever. That 06.04.2021 at late night my husband has pressed pillow over my face with an intention to kill me but somehow I rescued myself from grip of my husband on 07.04.2021 in the morning I left the rented place along with my minor children and take shelter in my paternal house at APC Sarani, Shibram Pally, Haider Para, Siliguri, P.O. – Haider Para, P.S – Bhaktinagar, Dist. Jalpaiguri.

After that on 15.04.2021 my husband came to my above mentioned paternal house and beg apology from me and my parents and said that he will never consume alcohol and other intoxicante substances. He also assured me and my minor children that he will never beat me and children again. For future of my minor children and with a hope of better conjugal life I along with my children return to the rented place of my husband on 16.04.2021.

On 13.05.2021 my husband came to our rented place at late night in intoxicated condition and without any reasonable cause my husband started to beat me up and when my minor children tried to stop my husband, he started to beat them also. Somehow we rescued ourselves from my husband's grip and came to my paternal house at APC Sarani, Shibram Pally, Haider Para, Siliguri, P.O. – Haider Para, P.S – Bhaktinagar, Dist. Jalpaiguri, at the time when we left the rented house my husband has been threatening to kill me along with my minor children.

Under the above circumstances I would like to request you to investigate the matter and take the legal action against my husband and save me and my minor son and daughter and do needful for the ends of justice.
