Sir,

With due respect, I am producing herewith the arrested accused person namely Ramesh Roy (55 yrs) S/O late Rajdeb Roy of Rajahowli, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 44 (Forty four) bottles of 60 up Himalayan Gold Country Spirit containing 600 ML in each bottle of Rs 100/- of each bottle.
2. 36 (Thirty six) bottles of 60 up Himalayan Gold Country Spirit containing 300 ML in each bottle of Rs 50/- of each bottle.
3. 11 (Eleven) bottles of HAYWARDS 5000 Super Strong Beer containing 650 ML in each bottle of Rs 130/- of each bottle.
4. 07 (Seven) numbers of paper made pouch of Officer Choice Deluxe Whisky containing 180 ml in each pouch of MRP Rs 140/- in each pouch.
5. 03 (three) bottles of Mc Dowell's No-1 Celebration Mature Rum containing 180 ML in each bottle of Rs 153/- of each bottle.

I beg to state that today i.e. on 29.05.21 at 18.15 hrs I received a secret source information that one person named Ramesh Roy of Rajahowli is selling ID liquor at near NJP Truck stand and he stored huge quantity of ID liquor in a Godwn at near NJP Truck stand for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 1286 dated 29.05.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, C/1053 Paresh Rava, CV/824 Niru Yadav, CV/116 Rohit Mahato left for Raja Howli to work out the information in hand. At about 18.35 hrs we arrived at Rajahowli and being shown and identified by the source we managed to intercepted one person who disclosed his name and identity as, Ramesh Roy (55 yrs) S/O late Rajdeb Roy of Rajahowli, PS- NJP, Dist.- Jalpaiguri and also disclosed that he is selling ID liquor at Truck stand for his illegal gain and stated also that he kept I/D liquor in a godwn at Truck stand. Being shown by the said Ramesh Roy I recovered and seized the above noted I/D liquor from the possession of accd Ramesh Roy under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search seizure & arrest was made in between 18.55 hrs to 19.45 hrs.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Ramesh Roy (55 yrs) S/O late Rajdeb Roy of Rajahowli, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
