## SUB : FIR FOR THEFT & BREAKAGE OF SHOWROOM'S ENTRANCE GLASS

Dear sir,

I would like to bring to your kind attention that, on the intervening night of 23.05.2021 a group of 10-15 people came to our showroom and started to break the RAILING placed as boundary wall. On seeing the same they were confronted by two numbers of security guard but they were over powered by the miscreants from across the Main National Highway along with the DRUG PEDDLER and DRUGGISTS which included few female members also in the group and they started pelting stone on our security guard who had no other option left but to retreat, they were able to however damage a portion of the show room's main TUFFENED Glass with a crack. They were unsuccessful in their motive on 23.05.2021.

However , on 24.5.2021 the same group of miscreants from across the Main National Highway along with the DRUG PEDDLER and DRUGGISTS which included few female members also in the group again made a attempt with more fierce and power and the 2nos. Of security had run for their life as they were equipped with iron rods and bamboo sticks, they were successful in breaking the MAIN TUFFEND GLASS placed in the entrance of the showroom due to which security of the entire premises have been breached, they were also successful in breaking and taking away the Boundary Iron Rails.

It is important for you to note that these DRUGGIST & PEDDLERS have been making several attempts in our premises which was reported on 1.11.20 & 2.11.20 when they had made a theft, same was reported to your station and officer from your office had made a visit and enquired about the matter.

We would like to bring to your kind attention that the entire vicinity has become the DEN for these DRUGGIST & PEDDLERS along with miscreants even during the day time.

We would request you to please enquire into the matter and take appropriate steps to make the place habitable and terror free.
