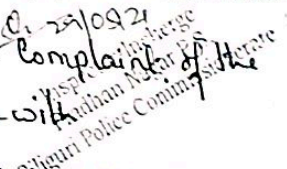


Sir,

In producing herewith one arrested accused person namely Kundan Barman(35), s/o- Harekrishna Barman of Durgaguri, near Rail line, PS- Pradhannagar, Dist- Darjeeling seized articles viz (i) 22 (twenty two) bottles of Royal Stag Premier Whiskey Containing 375 ML each Bottles,(ii) 20(twenty) bottles of 60up Himalayan Gold Country spirit each bottle containing 600 ml, (iii) 04(four) Pouch pack Officers Choice Deluxe Whiskey each containing 180 ml, (iv) 07(seven) bottles of TuborgPremium Strong Beere each containing 650 ML, (v) 04(four) bottles of Mc-Dowel No-1, Celebration Matured XXX Rum each containing 180 ML, (vi) 06(six) bottles of Officers Choice Deluxe Whisky each containing 180 ML (total approx-27 litre. value approx-16,000/=) as per the seizure list (which is enclosed herewith), I SI. Samik Paul of Pradhannagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against one the above noted accused person to the effect that on 29.05.21 at 19.05 hrs received a secret source information that one person illegally selling liquor inside his house situated at Durga Guri Rail line side under PS -Pradhannagar, Dist- Darjeeling without any valid license .

The information was diarised vide Pradhannagar PS, SPC GDE No-1635 Dt- 29.05.2021 accordingly I informed the matter to I/C Pradhannagar PS, SPC and as per kind direction myself along with ASI Ratan Pradhan, ASI Debasish Das,ASI Anup Sarkar, C-830 Pradip Roy, all of Pradhannagar PS left for the spot by govt vehicle to verify the veracity of source information. This refers Pradhannagar PS, SPC C.C No-1384/21 Dtd- 29.05.2021. On reaching at the spot I tried to call two disinterested witnesses but due to lockdown nobody came forward as witnesses and accompany us. Being identified by the source, it was found that the mentioned person was selling liquor inside his house to the customers. On seeing our team the customers and house flee away leaving the liquors from the backside towards Rail line. But police team managed to apprehend the above noted person. On being asked to the apprehend person it came to learnt that the he is owner of his house. He collected the above liquor from heather and thither for the purpose of selling to the common customers in high price during lock down at his house since long for his wrongful gain without any valid paper. Accordingly, conducted search of the said house cum shop and above noted liquors were recovered. Accordingly I seized the liquors from the house of accused person under proper seizure list duly signed by the witnesses. Seizure was made on 29.05.21 between 20:05 hrs to 21.05 hrs. Then I, labelled the seized articles duly signed by the apprehend person. On Examination it came to learnt that the house owner involved for running this illegal business of liquor at the said house cum shop under cover of darkness since long without any license or permission from the appropriate authority in the close vicinity of Public Place.

Hence I request you to start a specific case under proper section of Bengal Excise Act- 1909 as amended till date against the arrested accused Kundan Barman(35), s/o- Harekrishna Barman of Durgaguri, near Railline, PS- Pradhannagar, Dist- Darjeeling and kindly arrange for its investigation.
