In producing herewith eight (08) arrested accused persons who disclosed their name & identity as (i) Puchka Saha @ Gaurav Saha (18/yrs), S/O- Shri Baidya Nath Saha of Santipara Jalpaiguri near LIC office, PS-Kotwali, Dist-Jalpaiguri, A/P Pramod Nagar Colony, W/No-18, PS-Siliguri, Dist-Darjeeling (ii) Krishna Ch. Das (60yrs) S/O- Lt. Abinash Ch. Das of Rabindra Nagar near Rabindra Sangha Club, PS-Siliguri, Dist-Darjeeling, (iii) Smt. Santi Das (40yrs) W/O- Mittyun Das of Pramod Nagar Colony, W/No-18, Hawkers Corner, PS- Siliguri, Dist-Darjeeling, (iv) Bhim Roy (53yrs) S/O- Lt. Ganesh Roy of Pramod Nagar Colony, W/No-18, PS- Siliguri, Dist-Darjeeling, (v) Sourab Adhikary (30yrs) S/O- Basudev Adhikary of Akrapur, Habra, PS- Habra, Dist. North 24 Parganas, A/P- C/O- Nilay Das, opposite side of Super Market, PS- Pradhannagar, Dist- Darjeeling, (vi) Partha Dey 33 years s/o- Palash Dey of Champasari, Jyotinagar Colony, W/No- 46, PS- Pradhannagar, Dist. Darjeeling, (vii) Raju Kr. Singh 31 years s/o- Joy Prakash Singh of Natunpara, Jalpai More, Ward no- 5, PS- Siliguri, Dist- Darjeeling and (viii) Tatai Sarkar 29 years s/o- Gopal Sarkar Deshbandhupara, APC Sarani, W/No- 30 near Bela Bekary, PS- Siliguri Dist. Darjeeling alongwith their vehicles bearing Reg Nos. viz- (i) One motor cycle bearing registration No- WB-74AA/4604, (ii) one Scooty bearing registration No- WB-74BB/9710 and (iii) one TOTO Rickshaw van bearing No- WB-73/F-1838. I SI Uttam Kumar Ghosh of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 29.05.2021 at 10.05 hrs during my R/T Mobile Van duty had been to Venus more area under Siliguri PS and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons. Three of them namely Partha Dey, Raju Kr. Singh and Tatai Sarkar roaming there with their vehicles noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of India duly promulgated in order No. 40-3/2020-DM-I(A), Govt. of India Ministry of Home affairs dated 24.03.2020 & MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV dated 27.04.2020 and Govt. of West Bengal order no- 134-Pr. Sec (Tr) dated 04.06.2020 & Order no- 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of India duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accordingly, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
