In producing herewith seven (07) arrested accused persons who disclosed their name & identity as (i) Ganesh Roy (43) years s/o- Prafulla Roy of Jyotinagar, Jhankar More W/No- 4, PS- Siliguri Dist- Darjeeling, (ii) Rihit Hela (21) years s/o- Babulal Hela of Subhaspally Lichubagan, W/No- 18, PS- Siliguri Dist- Darjeeling, (iii) Pankaj Bajoria (47) years s/o- Giridharlal Bajoria of 118, Meghnath Saha Sarani Pradhan Nagar, W/No- 2, PS- Pradhanagar, Dist. Darjeeling, (iv) Sadhan Saha Chowdhury (59) years s/o- Khagendranath Saha Chowdhury of Madhya Santinagar near Shantinagar Yuba Sangha, W/No- 36, PS- Bhaktinagar, Dist- Jalpaiguri, (v) Dipak Sarkar (32) years s/o- Dhiren Sarkar of Kawakhali Netaji more, PS- Matigara, Dist- Darjeeling, (vi) Dayal Mandal (52) years s/o- Lt. Sarot Mandal of 1 No. Tikiapara, W/No- 28, PS- Siliguri, Dist. Darjeeling and (vii) Subhodip Guha (34) years s/o- Dilip Guha of Deshbandhupara, W/No- 30 near Tarai Tarapada School, PS- Siliguri, Dist. Darjeeling alongwith their vehicles viz- (i) One Yellow colour Rickshaw bearing SMC No- 348, (ii) One blue colour Scooty Honda bearing registration No- WB-74-BD/0312, (iii) One black colour ECO Ford car bearing registration No- WB-74AT/3779, (iv) one red colour TOTO bearing registration no. WB-73F/5170 and (vi) one yellow colour rickshaw bearing SMC No- 4629. I SI Swapan Basu Biswas of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 29.05.2021 at 17.35 hrs during my R/T Mobile Van duty had been to Airview More, Siliguri and found the above noted persons were gathered/ roaming there along with their vehicles noted above without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.


Hence, they violated the order of Govt. of India duly promulgated in order No. 40-3/2020-DM-1(A), Govt. of India Ministry of Home affairs dated 24.03.2020 & MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV dated 27.04.2020 and Govt. of West Bengal order no- 134-Pr. Sec (Tr) dated 04.06.2020 & Order no- 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons, have intentionally refused to comply with the order of Govt. of India duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
