Sir,

In producing herewith 06 (Six) arrested persons namely (i) Kamal Roy-40yrs s/o Purnadev Roy Of Anilnagar, Pitiramjote, PS Matigara Dist Darjeeling (ii) Sourav Kumar-29yrs s/o Sakindar Poddar of Santoshinagar ward no-V, PS Siliguri Dist Darjeeling (iii) Naresh Barman-44yrs s/o Jyotish Barman of Durganagar ward no-IV PS Siliguri Dist Darjeeling (iv) Sanju Das-24yrs s/o Lt Upendra Das of Santoshinagar Ward No-V, PS Siliguri Dist Darjeeling (v) Mangal Sahu-68yrs s/o Lt Tribhuban Sahu of Natunpara Ramghat ward no-V, PS Siliguri Dist Darjeeling (vi) Binod Rai-44yrs s/o Benu Rai of Ganganagar Road No-2 ward No-IV PS Siliguri Dist Darjeeling along with all connecting paper.

I, SI Srimanta Chatterjee of Khalpara TOP under Siliguri PS, SPC do hereby lodge complaint against the above noted arrested persons, to the effect that while on performing Special mobile van duty against violating COVID-19 rules & Guidelines myself along with ASI Aminul Islam, ASI Kalachand Singha, C/1187 Ganesh Sarkar and CVF/980 Ranjan Ojha all of Khalpara TOP-II under Siliguri PS had been to Santoshinagar Machli bazar, Siliguri at about 18.45PM (Khalpara TOP GDE No- 938 dated 29.05.21) and found that the above noted persons had made unnecessary gathering at the public places without wearing mask. On being asked the above noted persons stated that they were well aware of the COVID-19 pandemic situation and disobeyed the Govt guidelines without any valid reason.

Hence all of them violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, & order No-629-1SS/2M-22/2020 dated 05.05.21 & Order No-647-1SS/2M-22/2020 dated 15.05.21 that wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation and to prevent spread of COVID-19. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID- 19 throughout the Country. Accordingly I arrested them after issuing proper arrest memo and maintaining health protocols ensure their safety and security.

So, I therefore request you for starting a specific case under proper section of law against the above noted arrested accused persons namely (i) Kamal Roy-40yrs s/o
