

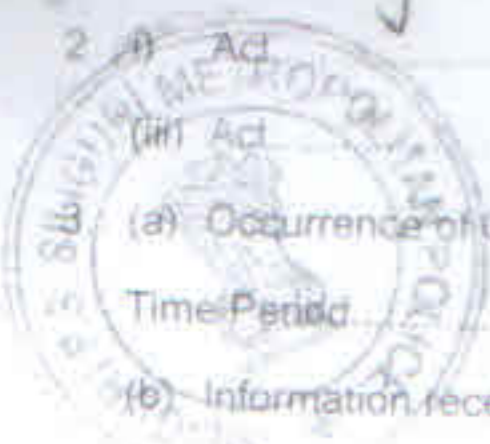

Sir,

In producing herewith arrested accused person namely Pradip Biswas (42) S/O Late Ashutosh Biswas of Sarbohara Colony back side Amantran Bastralyaya, Ward No. 28, PS-Siliguri, Dist- Darjeeling along with seized articles vize- i) 295 (two hundred ninety-five) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amount of 295/Rs 100/- =RS.29500/-) ii) 14 sealed bottles of McDowell's No.1 superior Whisky Original containing 180 ml each having Batch no. 002-2APR21 and Mfg Date 23.04.21 @ Rs. 174/- each (amount 14x Rs.174 = Rs. 2436/-) as per seizure list.

I, SI Uday Chakraborty of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Pradip Biswas (42) S/O Late Ashutosh Biswas of Sarbohara Colony back side Amantran Bastralyaya, Ward No. 28, PS-Siliguri, Dist-Darjeeling and his brother namely Dipak Biswas who was absconding from the spot to the effect that on 29.05.21 at 20.05 hrs I received a source information that the above noted persons were busy to sale Id liquor illegally at his house situated at Sarbohara Colony back side Amantran Bastralyaya under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 1533 dated 29.05.21 and informed the fact to I/C Siliguri PS. As per his direction of I/C Siliguri PS, I along with ASI Subir Sen, ASI Siben Sarkar, CV/622 Ramanath Barman and CV-283 Prosenjit Dey left for Sarbohara Colony back side Amantran Bastralyaya Siliguri PS vide Siliguri P.S GDE NO: 1534 to verify the veracity of the information. On reaching at 20.15 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person and another one person tried to escape from the spot, but we managed to apprehend the above noted person and on interrogation, the above noted person disclsed his identity as noted above. The above noted apprehend person also stated that he along with his brother namely Dipak Biswas were busy to sale the illegal liquor but his brother managed to escape from the spot. On searching we found that i) 295 (two hundred ninety-five) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amount of 295/Rs 100/- =RS.29500/-) ii) 14 sealed bottles of McDowell's No.1 superior Whisky Original containing 180 ml each having Batch no. 002-2APR21 and Mfg Date 23.04.21 @ Rs. 174/- each (amount 14x Rs.174 = Rs. 2436/-) which was kept concealed in their house. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he along with his brother Dipak Biswas are doing this liquor business since last eight (08) months approx for wrongful gain. Accordingly I seized

the same in presence of witness duly signed by them. The seizure and label was made in between 21.05 hrs to 21.55 hrs. On being asked he stated that he used to sale the same to locality without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him U/S-41 Cr.P.C after observing all sorts' of rules for selling the said country made sprit without any valid license.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused persons namely Pradip Biswas (42) S/O Late Ashutosh Biswas of Sarbohara Colony back side Amantran Bastralyaya, Ward No. 28, PS-Siliguri , Dist- Darjeeling and his brother Dipak Biswas under proper section of law and arrange for its investigate.
