

Sir,

In producing herewith arrested 03(Three) accused person namely; 1) Md Meghu (65 yrs) s/o Late Md Samjan, 2) Md Hussain (32 yrs) s/o Md Meghu 3) Hasina Khatun (36 yrs) w/o Maifuz Alam all of Tiger Busty, PS-Bagdogra, Dist-Darjeeling along with the following article seized under proper seizure list that :

- (a) One packet containing said to be Ganja wrapped with red plastic and brown cello tape weighing 12.400 kgs, marked as **Exhibit-A**,
- (b) One packet containing said to be Ganja wrapped with white paper and white cello tape weighing 200 gram taken out as sample from Exhibit -A, marked as **Exhibit- A-1**,
- (c) One packet containing said to be Ganja wrapped with green plastic and transparent cello tape weighing 12.500 kgs, marked as **Exhibit-B**,
- (d) One packet containing said to be Ganja wrapped with white paper and white cello tape weighing 200 gram taken out as sample from Exhibit -B, marked as **Exhibit- B-1**,
- (e) One white gunny bag in which Exhibit- A, A-1, B, B-1 were kept and marked as Exhibit- "C".
(Total ganja weiging 25.300 kgs)

I, SI Mohini Barman of Bagdogra P.S. S.P.C do hereby lodge a written complaint against the above mentioned arrested persons to the effect that today on 29.05.2021 at 11.35 hrs. an information received that some people of Suryanagar Tiger busty PS, Bagdogra would proceed towards the house of Md. Meghu and others of Tiger busty under Bagdogra PS, with a view to attack their house over the issue of selling illegal NDPS substance. I shared the information with O.C. PS accordingly, myself accompanying SI J. V. Lepcha, Officer In Charge, Bagdogra PS, I along with ASI Dharendra Nath Mondal, ASI Abu Taleb, Const- 410 Mantosh Singh, LC/ 1311 Chamta Thapa LC/ 385 Guddi Dukpa, VP/01 Ansalam Kujur, VP/02 Pradip Roy, CV/389 Janak Singha all of Bagdogra PS, SPC left for Tiger busty to work out the information, noted vide GDE No. 1319 Dated 29.05.2021. At around 11.40 hrs on arrival at Tiger Busty, found mob of approx 40/45 people of Suryanagar had already started dismantling some house and there was huge law and order problem.

Meanwhile, my source informed me that Md. Meghu, his son Hussain and Hasina Khatun, who all deal in contraband substance fled with huge gunny bag allegedly containing Ganja before coming of mob from the house of Md. Meghu and was seen going towards Bagdogra Railway Station approach Road form backside road. Amidst huge law and order problem, I shared the information with O.C. Bagdogra PS, who was handling law and order problem with other officers and force. He directed me and Const- 410 Mantosh Singh, LC/ 1311 Chamta Thapa LC/ 385 Guddi Dukpa, VP/01 Ansalam Kujur, CV/389 Janak Singha to

out the information. I, accordingly along with above noted force left to work information.

I along with force reached at approach road and searched towards Railway Station but they could not be seen. I along with force accordingly started looking for them towards approach road crossing. On arrival at approach road crossing at around 12.05 hrs, I could see on the left side above noted persons standing and holding the above noted gunny bag, containing of suspected to be Ganja. Within no time, I along with force could cordon them and we disclosed our identity as Police officers from Bagdogra PS. On interrogation they disclosed their name and address as noted above and on further interrogation regarding contents inside said gunny bag, they all stated they were shifting ganja for concealment as people of Surya Nagar were preparing to attack on their house with allegation that we sell Drugs and Ganja. I also could smell Ganja or odour of Ganja was coming out from the said gunny bag. Then, I called two persons namely (i) Md. Tabir s/o Md. Kamrul and (2) Ajit Ghatani s/o Late Kul Bahadur Ghatani both of Suriyanagar Tiger Busty, PS Bagdogra, Dist. Darjeeling and shared the information in hand with them and requested them to act as witness during search and seizure, if any, in writing and both agreed with the proposal. I sent CV/389 Janak Singha to bring weighing machine, gala seal, white papers, cello tape, etc. from PS.

I then gave them option notice in writing whether they wanted to be searched in presence of an Executive Magistrate or Gazetted Officer and they gave in writing that they would prefer to be searched in presence of Executive Magistrate or Gazetted Officer. Accordingly, I informed the matter to O/C Bagdogra PS and he informed me over mobile phone to send one requisition to Shri. Pasang Topgay Bhutia, Asstt. Commissioner of Police, Traffic(West), Siliguri Police Commissionerate as per his kind order, at 12.35 hrs, I sent a letter through C/410 Mantosh Singh to Shri. Pasang Topgay Bhutia, Asstt. Commissioner of Police, Traffic(West), Siliguri Police Commissionerate, who was deputed as Special Executive Magistrate of SPC, informing him regarding the interception of the said accused persons in possession with suspected to be Ganja, with a request to come him at near Approach Road, Bagdogra Railway Station under Bagdogra P.S, SPC to be present and to supervise the search and seizure and to perform Magisterial function. Accordingly, at 13.40 hrs Shri. Pasang Topgay Bhutia, Asstt. Commissioner of Police, Traffic(West), Siliguri Police Commissionerate, arrived at the spot to perform magisterial function. He disclosed his name and designation and informed both the witnesses and apprehended three accused persons that he was present to perform Magisterial function. I offered the independent witnesses and the accused person to search our Police Party as per provisions of law but, they did not search the police party. Then, under the supervision of Shri. Pasang Topgay Bhutia, Asstt. Commissioner of Police, Traffic(West), Siliguri Police Commissionerate, I searched the apprehended said persons and the female person by L/C 385 Guddi Dukpa keeping their decency. On search of gunny bag in presence of Shri. Pasang Topgay Bhutia, Asstt. Commissioner of Police, Traffic(West), Siliguri Police Commissionerate recovered (1) One packet containing said to be Ganja wrapped with red plastic and brown cello tape, on weighing found 12.600 kgs. (2) One packet containing said to be Ganja wrapped with green plastic and transparent cello tape, on weighing found 12.700 kgs and on interrogation they failed to produce any valid document in support of them for the same.

In presence and under the supervision of Shri. Pasang Topgay Bhutia, Asstt. Commissioner of Police, Traffic(West), Siliguri Police Commissionerate and in presence of witnesses and accused persons, I cut opened the two packets and took out 200 grms ganja from each packet as sample, marked as exhibits, sealed and seized as follows observing all formalities;

- (a) One packet containing said to be Ganja wrapped with red plastic and brown cello tape weighing 12.400 kgs, marked as **Exhibit-A**,
- (b) One packet containing said to be Ganja wrapped with white paper and white cello tape weighing 200 gram taken out as sample from Exhibit -A, marked as **Exhibit- A-1**,
- (c) One packet containing said to be Ganja wrapped with green plastic and transparent cello tape weighing 12.500 kgs, marked as **Exhibit-B**,
- (d) One packet containing said to be Ganja wrapped with white paper and white cello tape weighing 200 gram taken out as sample from Exhibit -B, marked as **Exhibit- B-1**,
- (e) One white gunny bag in which Exhibit- A, A-1, B, B-1 were kept and marked as **Exhibit- "C"**.

The whole process of seizure was made in between 14.15 hrs to 15.05 hrs and arrested the above noted accused person U/S 41 CrPC informing the ground of their arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the said accused person namely 1) Md Meghu (65 yrs) s/o Late Md Samjan, 2) Md Hussain (32 yrs) s/o Md Meghu 3) Hasina Khatun (36 yrs) w/o Maifuz Alam all of Tiger Busty, PS-Bagdogra, Dist-Darjeeling and arrange for its investigation.


