In producing herewith 08 (Eight) arrested accused persons who disclosed their identity as 1. Toton Haldar (22), S/O Nikhil Haldar of Rathkhola, Sahapara, PS-Jaynagar, Dist- South 24 Parganas, 2. Suman Paul (32), S/O Rabindra Nath Paul of Bhanu Nagar, Near Lions Club, PS-Bhaktinagar, Dist-Jalpaiguri, 3. Sourabh Das (20), S/O Subhas Das of Ghugumali, Das Para, Ward No-37, PS-Bhaktinagar, Dist-Jalpaiguri, 4. Kanai Das (20), S/O Akhil Das of Do, 5. Surajit Das (26), S/O Swapan das of Bhanu Nagar, Near Sai Nursing Home, PS-Bhaktinagar, Dist-Jalpaiguri, 6. Abdul Seikh (25), S/O fajul Seikh of Pakur, Near Menka Para, PS-Pakur, Dist-Pakur, State-Jharkhand, 7. Raj Kumar Roy (40), S/O Ramjit Roy of Chayan Para, Near Dumping Ground, PS-Bhaktinagar, Dist-Jalpaiguri, 8. I, ASI Asit Saha of Bhaktinagar PS, SPC do hereby lodge complaint against the above noted persons, to the effect that 30.05.2021 while I along with officer and force were performing lock down patrolling duty in c/w COVID-19 at Sevoke Road, Near Check Post, under Bhaktinagar PS, Dist-Jalpaiguri. At around 16.30 hrs to 18.05 hrs during my patrolling duty found the above noted persons were moving without any mask and without any reason. Thereby making unnecessary gathering at Sevoke Road, Near Check Post, under Bhaktinagar PS, Dist-Jalpaiguri. On being asked the above noted persons stated that they were well aware of lock down and pandemic Covid-19 situation and they supposed to wear face mask. Further I requested them to wear Mask and maintain the social distance but they did not pay any heed. Hence they all violated the order of Govt. of India duly promulgated in order no 40-3/2020-DM-I (A), Govt. of India Ministry of Home Affairs Dated 24.03.2020. They all also violated the order of Govt. of India duly promulgated in order no 40-3/2020-DM-I (A), Govt. of India Ministry of Home Affairs Dated 24.03.2020 and MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV Dt. 27/04/20 & Govt. of WB order No - 79-CS/2020 Dated- 12.04.2020 and advisory issued vide no- 715-Home 9Cons/RIM (Cons)-92/2021 Dated- 17.04.2021 and Memo No- 486-CS/2021 Dated- 24.04.2021 and Order No 647/ISS/2M-22/2020, dated 15.05.2021, The above noted persons have intentionally refused to comply with the order of Govt. of India and Govt. of West Bengal duly promulgated in view of break- out of Pandemic COVID- 19 throughout the Country. Finding no any other alternative I arrested them u/s 41 Cr.p.C under proper memo of arrest after explaining the charge against them.

Under the above circumstance I request you that a specific case may kindly be started U/S 188/269/270 IPC R/W Sec 51(b) Disaster Management Act. 2005 against the above noted 08 (Eight) arrested accused persons and arranged proper investigation of the case.
