Sir,

In producing here with the one accused person namely Raju Singh Biswakarma (48) S/O- Late Gokul Singh Biswakarma C/O- Dikki Tamang W/O- Late Purna Tamang of Shastrinagar near Kali Mandir PS- Bhaktinagar Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 38 (thirty eight) bottles of Himalayan Gold 60 up country spirit each containing 600 ml.
2. 03 bottle of Imperial blue classic grain whisky each bottle containing 750 ml .
3. 48 pouch packet of officer's choice each packet containing 180 ml,
4. 03 bottle of Tuborg strong beer containing 650 ml.
5. One Pet bottle Officers choice containing 750 ml,

I, ASI Rabin Lama of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complaint against the above noted accused person to the effect that on 30/05/2021 at 18.15 hrs received an information from source that one person namely Raju Singh Biswakarma has gathered huge quantity of illegal liquor in his house for selling the same to his design customers for his wrongful gain . Accordingly diarized the fact in GD vide Bhaktinagar PS GDE no 158 dated 30.05.2021 and shared the information with I/C, Bhaktinagar P.S. and as per his kind instruction myself along with CVF- 614 Sumit Kr Roy and CVF- 935 Biplab Roy ,CVF, 619 Dharmendra Roy accompanied with SI Sajal Roy and SI Sibdhan Karmakar left for Shastrinagar to verify the veracity of the information . At 18.35 hrs we reached at the spot i.e Shastrinagar in the house of Raju Singh Biswakarma and as identified by the source our police party cordoned the house and conducted raid and recovered the above noted articles from his house from the exclusive possession of the above noted accused person namely Raju Singh Biswakarma. On demand he could not produce any valid Licence/documents in support of said liquor. He became nervous and admitted his guilt before us and stated that he used to sale the same to his design customers as well as in open market at Shastrinagar area for his wrongful gain. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and level and took signature of the accused person . The seizure was made in between 19:05 hrs to 19:35 hrs). As he violated the rules and norms of Bengal Excise Act as such I arrested the accused person u/s 41 Cr.P.C and issued arrest memo appraising him the ground the of arrest.

I, therefore pray before your kind honour that a specific case may be started against the accused person namely Raju Singh Biswakarma (48) S/O- Late Gokul Singh Biswakarma C/O- Dikki Tamang W/O- Late Purna Tamang of Shastrinagar near Kali Mandir PS- Bhaktinagar Dist- Jalpaiguri under proper section of law and arrange for its investigation.
