rash and negligent driving by vehicle bearing Registration No. WB73C 8605.

Sir,

In connection with the above subject, I, Sri Sanarfan Tamang, S/O Sri Saran Kumar Tamang, resident of Debidanga, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling would like to inform you that my father, who was riding a scooter bearing No. 74AT 6492 was hit by a Bolero Camper bearing the No. WB73C 8605. My father was returning home after a Covid 19 test at Bengdubi Army Hospital. He had gone to get himself tested as my mother is Covid positive and is presently admitted at Railway Hospital in NJP where she is undergoing treatment.

The accident occurred at about 10.30 am ^{on} 29.5.21 at Champasari Anchal near first bridge. My father was subsequently taken to Chennai Nursing Home, near Naa Durga petrol pump, Debidanga where he was administered first aid and advised a CT scan and X-ray by the doctor. My father was then taken to Anandaloke Diagnostic Centre for the above examinations and on perusing the reports of the same, the doctor advised him to be admitted. So he is presently admitted at North Bengal Neuro Clinic at Pradhan Nagar, Siliguri and undergoing treatment for a head injury that included a blot clot in his skull and a fractured shoulder bone.

Hence, I would like to request you to kindly look into the matter and take necessary action against the driver of the above vehicle for rash and negligent driving.
