Sir,

I, SI Samik Paul presently posted under your kind disposal at Pradhannagar Police Station, SPC would like to lodge this written complaint against One (01) arrested accused person named Md Sahil Sk (24) @ Seru S/O Lt Md. Saheb Sk of Champasari Anchal, Normada Bagan, P.S-Pradhannagar, Dist. Darjeeling who had been arrested for contravening the norms of NDPS Act and also would like to produce before you, following seized articles under seizure as per seizure list:

- i) 257 grams of Brown Sugar, which marked as Exhibit-A,
- ii) .05 grams of Brown Sugar taken out from Exhibit A, as sample for examination and marked as Exhibit A1
- iii) Cash Rs. 24000 /-(Twenty Four thousand) having denomination (i)100 x 120, (ii)50 x 160, (iii)10 x 400
- iv) One Activa Scooty (Blue color) having Reg. No-WB 74 AU 2315.
- v) One Small electronic weighing machine
- vi) One Small plastic Spoon.
- vii) One VIVO mobile phone having IMEI1:866066037114596, IMEI2: 866066037114588, which connection no. 7908323243

In this regard I beg to state that today i.e. on 30.05.2021 at 18:40 hrs myself received a secret source information that one person named Md Sahil Sk @ Seru carrying a good quantity of Brown Sugar from Normada Bagan Side in his possession by a scooty bearing reg no. WB 74AU 2315 which is to be sell the same at Siliguri area Wasting no time I diarized the information to Pradhannagar PS General Diary vide GDE No. 1690, Dt. 30.05.2021 and consequently informed of the tip off to you for kind instruction. On being directed, myself along with ASI. Debasish Das, ASI Ratan Pradhan, ASI Ashit Kr Singh, CV 131 Ranjan Sharma, CV 646 Baban Das, CV/645 Pankaj Gupta left PS at 18.50 vide P.D.N PS GDE No. 1691 dtd.30.05.2021 & Vide M.C.C no. 1391/21 dtd.30.05.2021 for perusing the information along with the IO Kit including Weighing machine, etc. This is to note here that there was no enough time to obtain search warrant and there was a chance to miss the information, hence I did not obtained any search warrant.

While going to Champasari More under Pradhannagar PS. After arriving Champasari more under Pradhannagar PS, SPC at 19.05 hrs, I contacted two persons namely 1) Kaushik Roy (21) S/O Kamal Roy of Champasari Anchal, Normada Bagan, P.S-Pradhannagar, Dist. Darjeeling & 2) Sri Rajdeep Lohar (26) S/O Raju Lohar of Salugara Pipe Line near Bangla High School, P.S. Bhaktinagar, Dist. Jalpaiguri and make them aware of the information in hand and requested them to act as witness if any search and seizure would be made necessary upon which they agreed.

Thereafter we along with the independent witnesses started weighting, after a while at 19.15 hrs the source that was waiting for us there pointed towards a person who was coming from Normada Bagan Side suspiciously with a blue colour Scotty. we cordoned the said person from all sides to avoid


any chance of him fleeing away. Thereafter we disclosed our identity and the information in hand and stated him that he will be searched in person for the purpose. As the person trying to hide something article from Police there was strong reason to believe that the article is very much suspicious and it is brown sugar. Thereafter I gave him the option to be searched before a Magistrate or a Gazetted Officer upon which he agreed to be searched before a gazetted officer and I gave him the option in written & read it out and after heard this he agreed and put his signature.

Consequently I contacted with Sri Subasish Chaki, I/C Pradhannagar PS and requested him to come to the spot to act as a gazette officer and supervise the entire process of search and seizure. Sri Subasish Chaki, I/C PS arrived at the spot at 19.50 hrs and thereafter the process of the search was conducted. Before conducting the search self search of mine and Sri Subasish Chaki, I/C PS had been conducted by the detained person Md Sahil Sk @ Seru and a memo had been given to him to the effect. On being searched from his possession one Plastic Packet containing some Brown Sugar, some cash, one Small electronic weighing machine, One Small plastic Spoon has been recovered from his Scotty dickey and one Vivo mobile phone recovered from his trouser right pocket .


Thereafter I started weighting the Packet of brown sugar with a weighing machine kept with us for the purpose of weighing and on weighing the quantity of the recovered Brown Sugar turned out to be 257 grams from 01 (one) packet kept in his Scotty dickey . I seized the recovered Brown Sugar 257 grams, cash of Rs.24000/-, one Small electronic weighing machine, One Small plastic Spoon, One Activa Scooty (Blue color) having Reg. No-WB 74 AU 2315 & One VIVO mobile phone having IMEI1:866066037114596, IMEI2: 866066037114588 which connection no . 7908323243, in-between 20:10 hrs to 21:15 hrs by preparing a seizure list duly signed by the accused person, independent witnesses. In the seizure list I obtained the signature of Sri Subasish Chaki, I/C Pradhannagar PS, SPC and put my signature too. The seized mother packet of Brown Sugar had been labeled as Ex - A and I also took sample from the mother packets .05 grms Brown Sugar and Labeled MARKED AS EX-A1. The apprehended accused Md Sahil Sk @ Seru had been arrested by me at 21.20 hrs by issuing a proper Arrest Memo for contravening the norms of NDPS Act, on interrogation he stated that he purchased the Brown Sugar from Malda Dist and we are returned back to PS.

In the above circumstance, I pray before you to take charge the seized articles and also to start a specific case against Md Sahil Sk (24) @ Seru S/O Lt Saheb Sk of Champasari Anchal, Normada bagan, P.S. Pradhannagar, Dist. Darjeeling and others Under proper section of law and oblige thereby.
