In producing herewith the arrested accused person namely Uttam Thapa (43y) s/o Buddha Thapa of Laltnagar, Vivekanandapally, PS-Bagdogra, Dist-Darjeeling alongwith the seized Articles viz (1) 15(fifteen) sealed bottles of 180 ml. of Royal Lancer Whisky each, out of which 01 (one) bottle is taken as sample marked as "A-1", (2) 14(fourteen) sealed bottle of 180 ml of Sterling Reserve B7-Whisky each, out of which 01(one) bottle is taken as sample marked as "B-1" (3) 08(eight) sealed bottles of 180 ml. of Imperial Blue Whisky each, out of which 01 (one) bottle is taken as sample marked as "C-1", (4) 28 (twenty eight) sealed Pouch packet of 180 ml. of Officer Choice Delux Whisky each, out of which 01 (one) pouch packet is taken as sample marked as "D-1", (5) 06(six) sealed bottles of 180 ml. of McDowel's No1 Celebration RUM each, out of which 01 (one) bottle is taken as sample marked as "E-1", (6) 15(fifteen) sealed bottles of 650 ml. of Kingfisher Strong Premium Beer each, out of which 01 (one) bottle is taken as sample marked as "F-1", (7) 02(two) sealed bottles of 750 ml. of Medowel's No1 Superior Whisky each, out of which 01 (one) bottle is taken as sample marked as "G-1", and (8) 06(six) sealed bottles of 600 ml. of 60 UP Country Spirit, Himalayan Gold each, out of which 01 (one) bottle is taken as sample marked as "H-1". I beg to submit that today on 30.05.2021 at 18.45 hrs received an information vide Bagdogra P.S GDE No. 1402 dt. 30.05.2021 to the that one person has stored huge quantity of illegal Country Spirit and Foreign liquor in his house at Lalitnagar, Vivekanandapally under Bagdogra P.S and acting on source information, I ASI Dharendra Nath Mondal alongwith ASI Abu Taleb, Const- 410 Mantosh Singh, VP/01 Ansalam Kujur, VP/02 Pradip Roy and CV/389 Janak Singha all of Bagdogra PS, SPC, left for Lalit Nagar, Vivekanandapally, vide Bagdogra P.S GDE No. 1403 dt. 30.05.2021 and on indication of source, I alongwith the accompanied officer and force conducted raid in the Fast Food Shop attached to the house of accused Uttam Thapa and on search found huge quantity of aforesaid items were stored in his Fast Food Shop. On being asked the accused disclosed his identity as mentioned above and on demand he failed to produce any valid license or documents in support of him for the same. He also opened his mouth that he stored the said Articles with a view to sell to the customers for his wrongful gain and he ran his this business since long under the design of Fast Food Shop. I therefore, seized aforesaid Article under proper seizure list and leveled duly signed by him and witness. The entire seizure was made in between 19.35 hrs to 20.15 hrs. Subsequently, I arrested the said accused person observing all formalities and narrated the


