Sir,

In producing herewith the arrested accused person namely Raju Pandey (23y) s/o Ram Chandra Pandey of Pramod Nagar, PS-Bagdogra, Dist-Darjeeling along with the seized articles viz (1) 20(twenty) sealed bottles of 600 ml. Boss 60 up country spirit, Himalayan Gold each out of which 01 (one) bottle is taken as sample marked as "A-1", (2) 08(eight) sealed bottles of 650 ml. of Kingfisher Strong Premium Beer each, out of which 01 (one) bottle is taken as sample marked as "B-1" I beg to submit that today on 31.05.2021 in course special raid duty, received a secret source information that one person was carrying suspicious goods from Daragaon to Bihar More side and at 20.15 hrs acting on source information, I ASI Dharendra Nath Mondal alongwith ASI Abu Taleb, Const- 410 Mantosh Singh, VP/01 Ansalam Kujur, VP/02 Pradip Roy and CV/389 Janak Singha all of Bagdogra PS, SPC intercepted one suspected person under indication of the source at Daragaon near Gumba under Bagdogra P.S who was found carrying one bag in his left hand and one cartoon on his shoulder gripped by his right hand and on being asked he disclosed his identity as mentioned above. On searching, recovered the said sealed bottles containing of country spirit in the plastic bag and said sealed bottles containing of Kingfisher Strong Premium Beer in the cartoon and on demand the said accused person failed to produce any valid license or documents in support of him for the same. I therefore, seized the same under proper seizure list and leveled duly signed by him and witnesses accordingly. The entire seizure process was made from 20.15 hrs to 21.15 hrs and then arrested the said accused person observing all formalities and narrated him the ground of his arrest.

During interrogation he confessed his guilt that he was carrying the said seized Articles with a view to sell the same illegally to the customers in his locality for his wrongful gain and he ran his business since long without any valid document or license and maintain his family by doing of such type of business.

Under the above circumstances I pray to your honour that a specific case under proper section of law may kindly be registered against Raju Pandey s/o Ram Chandra Pandey of Pramod Nagar, PS-Bagdogra, Dist-Darjeeling and arrange for its investigation.
